My father was a career non-commissioned U.S. Army officer and my mother was a first-generation German immigrant. From my father I learned the importance of sacrifice, hard work, and public service; from my mother, who was never afforded the opportunity of a college education, I learned the importance and value of higher education, along with the importance of common sense and an even temper. As a result, I am the first and only person in my family to have graduated from college (and of course, law school), having paid my own way through college without student loans, often working two jobs to afford the tuition and living expenses. Since having the privilege of being appointed to the bench in August 2011, I have striven each and every day to bring to the bench, and as a practicing attorney, the same level of hard work, respect, dedication, common sense, and even temperament that I learned from my parents and from my life experiences.

In August 2008, I authored an opinion letter on behalf of my client, a subdivision's homeowners' association, in connection with it obtaining financing from First Bank to perform significant road repairs in the subdivision. Subsequently, among other things, the enforceability of First Bank's loan was put at issue in separate litigation before the Honorable Sandra Farragut-Hemphill. In an interlocutory judgment, Judge Hemphill held First Bank's loan unenforceable as to the subdivision, and its homeowners' association. While this underlying litigation before Judge Hemphill was pending, First Bank filed a separate suit, alleging negligent misrepresentation by my law firm and me due to First Bank's reliance upon my opinion letter in reaching its decision to approve the loan to the subdivision. Both my firm and I denied (and continue to deny) any liability, vigorously defended the suit, and expected to prevail. The two separate suits were ultimately consolidated, and ultimately all claims in the consolidated litigation were settled.

My first assignment upon taking the bench in August 2011 was to a domestic/family law docket. The assignment continued through 2014. I thoroughly enjoyed the docket, quickly recognizing that there was nothing more important or impactful that a judge does than decide the myriad of issues raised in domestic/family law cases. Along with the divorce and paternity cases, my domestic/family law docket also included a domestic violence order-of-protection docket with all of the complex issues raised in domestic violence cases. As a result, I have participated in various domestic violence seminars and symposiums including being invited to participate in a Domestic Violence Symposium sponsored by the Missouri Supreme Court in May 2015, and a Domestic Violence Seminar in June 2015 sponsored by the St. Louis Metropolitan Area's Domestic Violence Impact Panel, of which I am a member. Also, in September of this year, the St. Louis County Circuit Court will be launching its new Criminal Domestic Violence Court, of which I will be one of a handful of St. Louis County judges overseeing this specialized docket. During the Summers of 2014 and 2015 I guest lectured to OB/GYN residents at Mercy Hospital regarding domestic violence and the physicians' role in such cases as it relates to the legal system. I have been invited to guest lecture again this summer.

In January 2015 I was assigned to an associate criminal docket, wherein I handle all facets of pre-trial criminal matters, including arraignments, bond hearings, preliminary hearings, guilty pleas, and misdemeanor bench and jury trials.
