

*Divergence in +/- indicators for percent/count change may indicate little overall change coupled with relatively wide annual fluctuation in case filings.

- On average, an estimated 24,500 cases were filed with the 30th Circuit Court and FCC each year.
 - Filings increased over the 5-yr period by almost 500 each year.
- By count, the largest increases in filings were in traffic/ordinance, associate civil/small claims and misdemeanor/etc. cases, while the largest decrease was with the FCC.
- Traffic/ordinance cases accounted for over two-fifths of the court's caseload, while misdemeanor/etc. accounted for one-fifth and associate civil/small claims and domestic relations for approximately one-tenth each (see below).
