Treatment Court Program Status


As of Dec. 31, 2013, there were 135 treatment court programs: 91 adult, 8 juvenile, 12 family, 19 designated DWI, 5 veterans courts serving 22 counties. The commission provided funding to 49 treatment court jurisdictions that include 126 treatment court programs.

Participants

As of Dec. 31, 2013, there were 3,607 individuals participating in treatment courts as measured by a count of cases. The adult category includes reintegration, veterans, and adult drug courts unless otherwise noted.


Total Participant Trend




Admissions

There were 150 admissions to treatment courts during this reporting period as measured by a count of cases. The number of admissions for calendar 2013 is 2,478. Re-entry also includes reintegration case types.

As of Dec. 31, 2013, there have been a total of 13,702 treatment court graduates.

A total of 676 babies have been born to female participants during treatment. **623 of these have been born drug free.**

- No drug free baby was born to participants that exited treatment court during this reporting period.
- No drug exposed baby was born to participants that exited treatment court during this reporting period.

Note: Current period plus prior period calendar year totals may not equal the current calendar year totals due to cases that were added after reports for the prior period were run.
