Treatment Court Program Status


As of Feb. 28, 2014, there were 135 treatment court programs: 91 adult, 8 juvenile, 12 family, 19 designated DWI, 5 veterans courts serving 22 counties. The commission provided funding to 49 treatment court jurisdictions that include 126 treatment court programs.

Participants

As of Feb. 28, 2014, there were 3,554 individuals participating in treatment courts as measured by a count of cases. The adult category includes reintegration, veterans, and adult drug courts unless otherwise noted.


Total Participant Trend




Admissions

There were 122 admissions to treatment courts during this reporting period as measured by a count of cases. The number of admissions for calendar 2014 is 337. Re-entry also includes reintegration case types.

As of Feb. 28, 2014, there have been a total of 13,957 treatment court graduates.

A total of 686 babies have been born to female participants during treatment. **633 of these have been born drug free.**

- Six drug free babies were born to participants that exited treatment court during this reporting period.
- No drug exposed baby was born to participants that exited treatment court during this reporting period.

Note: Current period plus prior period calendar year totals may not equal the current calendar year totals due to cases that were added after reports for the prior period were run.
