## Treatment Court Program Status


As of Jan. 31, 2014, there were 135 treatment court programs: 91 adult, 8 juvenile, 12 family, 19 designated DWI, 5 veterans courts serving 22 counties. The commission provided funding to 49 treatment court jurisdictions that include 126 treatment court programs.

### Participants

As of Jan. 31, 2014, there were 3,628 individuals participating in treatment courts as measured by a count of cases. The adult category includes reintegration, veterans, and adult drug courts unless otherwise noted.


Total Participant Trend




### Admissions

There were 205 admissions to treatment courts during this reporting period as measured by a count of cases. The number of admissions for calendar 2014 is 205. Re-entry also includes reintegration case types.

As of Jan. 31, 2014, there have been a total of 13,812 treatment court graduates.

A total of 680 babies have been born to female participants during treatment. **627 of these have been born drug free.**

- Two drug free babies were born to participants that exited treatment court during this reporting period.
- No drug exposed baby was born to participants that exited treatment court during this reporting period.

Note: Current period plus prior period calendar year totals may not equal the current calendar year totals due to cases that were added after reports for the prior period were run.
