

# Drug Courts Coordinating Commission

## Treatment Court Program Status


As of May 31, 2012, there were 141 treatment court programs: 89 adult, 13 juvenile, 14 family, 21 designated DWI, 1 reintegration, and 3 veterans courts serving 8 counties. The commission provided funding to 50 treatment court jurisdictions that include 131 treatment court programs.

### Participants

As of May 31, 2012, there were 3,507 individuals participating in treatment courts as measured by a count of cases. The adult category includes reintegration, veterans and adult drug courts unless otherwise noted.

**Total Participant Trend**




### Admissions



The following is known about all adult treatment court admissions for this reporting period:

- The average age at admission was over 33 years old.
- Admissions range in age from 17 to 72 years old.

### Exits

Termination includes termination, voluntary withdrawal, administrative discharge and dismissal docket types.

As of May 31, 2012, there have been a total of 11,550 treatment court graduates.

A total of 605 babies have been born to female participants during treatment. **557 of these have been born drug free.**

- Four drug free babies were born to participants that exited treatment court during this reporting period.
- No drug exposed babies were born to participants that exited treatment court during this reporting period. This is five consecutive reporting periods in which no drug exposed babies were born.

Note: Current period plus prior period calendar year totals may not equal the current calendar year totals due to cases that were added after reports for the prior period were run.
