

# Drug Courts Coordinating Commission

## Treatment Court Program Status


As of Oct. 31, 2012, there were 136 treatment court programs: 89 adult, 12 juvenile, 12 family, 19 designated DWI, 1 reintegration, and 3 veterans courts serving 8 counties. The commission provided funding to 50 treatment court jurisdictions that include 131 treatment court programs.

### Participants

As of Oct. 31, 2012, there were 3,595 individuals participating in treatment courts as measured by a count of cases. The adult category includes reintegration, veterans, and adult drug courts unless otherwise noted.


Total Participant Trend




### Admissions

There were 202 admissions to treatment courts during this reporting period as measured by a count of cases. The number of admissions for calendar 2012 is 2,280. Re-entry also includes reintegration case types.

The following is known about all adult treatment court admissions for this reporting period:

- The average age at admission was slightly over 32 years old.
- Admissions range in age from 17 to 65 years old.

### Exits

Termination includes termination, voluntary withdrawal, administrative discharge, and dismissal docket types.

As of Oct. 31, 2012, there have been a total of 12,095 treatment court graduates.

A total of 630 babies have been born to female participants during treatment. **579 of these have been born drug free.**

- Four drug free babies were born to participants that exited treatment court during this reporting period.
- One drug exposed baby was born to participants that exited treatment court during this reporting period.

Note: Current period plus prior period calendar year totals may not equal the current calendar year totals due to cases that were added after reports for the prior period were run.
