

# Drug Courts Coordinating Commission

## Treatment Court Program Status


As of Sept. 30, 2011, there were 143 treatment court programs: 89 adult, 16 juvenile, 13 family, 21 designated DWI, 1 reintegration, and 3 veterans courts serving 8 counties. The commission provided funding to 50 treatment court jurisdictions that include 131 treatment court programs.

### Participants

As of Sept. 30, 2011, there were 3,188 individuals participating in treatment courts as measured by a count of cases. The adult category includes reintegration, veterans and adult drug courts unless otherwise noted.


**Total Participant Trend**




### Admissions

There were 208 admissions to treatment courts during this reporting period as measured by a count of cases. The number of admissions for calendar 2011 is 1,912. Re-entry also includes reintegration case types.

- The average age at admission was over 32 years old.
- Admissions range in age from 18 to 68 years old.

### Exits

Termination includes termination, voluntary withdrawal, administrative discharge and dismissal docket types.

As of Sept. 30, 2011, there have been a total of 10,795 treatment court graduates.

A total of 580 babies have been born to female participants during treatment. **533 of these have been born drug free.**

- Seven drug free babies were born to participants that exited treatment court during this reporting period.
- No drug exposed babies were born to participants that exited treatment court during this reporting period. This is ten consecutive reporting periods in which no drug exposed babies were born.

Note: Current period plus prior period calendar year totals may not equal the current calendar year totals due to cases that were added after reports for the prior period were run.
