ENHANCEMENTS

Protection Order Changes

- ❑ Supreme Court Operating Rule 2 Changes - Effective January 1, 2010, Protection Order cases will only display if FULL ORDER is entered
- ❑ The Petitioner's Name is still protected once full order is issued

Litigant Name Search Results

- ❑ Parties w/o middle names now sort at the beginning of list instead of the end of the list

Party Information

- ❑ Ended Litigants will be searchable on Litigant Name Search
- ❑ Parties tab of Case.net will display ended litigants
- ❑ Parties tab will display End Date and End Reason
- ❑ Parties "Entered in Error" will not display
- ❑ Ended Attorneys will not display
- ❑ Paternity Respondents that are ended or do not have Judgment Against will not display
- ❑ Duplicated party entries in the court Case Management System only display once on Case.net

Finding an attorney to represent your interests, in court or otherwise, can be a difficult process. We hope the list of resources on this page will be beneficial to your search. The links provided below can provide such assistance as individualized referrals, referrals by geographic area, or referrals by practice area. As with any list of attorneys that can be found in your local telephone directory, however, a referral is not meant to be a substitute for the careful screening that each person should conduct before retaining an attorney. You are encouraged to ask any attorney you intend to retain for a list of references, areas of practice, or other suitable evidence of the attorney's ability to represent your interests.

The Missouri Bar Lawyer Referral Service can provide an individualized referral in substitute Missouri. Or, if you are a person whose income meets the guidelines for free legal services in certain civil cases, you can check Legal Services of Missouri for a legal aid office near you.

If you are searching for an attorney in metropolitan St. Louis, the Bar Association of Metropolitan St. Louis (BAMSL) maintains a Lawyer Referral and Information Service (LRIS) to assist you in your search.

For a referral in the Kansas City metropolitan area, the Kansas City Metropolitan Bar Association (KCMBA) also maintains a Lawyer Referral Service (LRS).

For referrals in southwest Missouri, the Springfield Metropolitan Bar Association (SMBMA) has a local Lawyer Referral Service as well.

If you are seeking assistance in a criminal case and are indigent or otherwise unable to afford a lawyer, you may be entitled to free representation by the Missouri State Public Defender System. If you do not qualify for free representation in a criminal case, please refer to the list of lawyer referral systems listed above.
