INSTRUCTIONS FOR CONSERVATION CITATIONS: *Do not call or go to the county courthouse before first reading these instructions. Take this notice with you if you consult an attorney. Some attorneys may not be familiar with Fine Collection Center procedures*

1. **IMPORTANT: You must respond to your citation within 30 days by pleading guilty and paying the fine or by pleading not guilty.** in which case your citation will be sent to the county prosecutor for disposition.. If you pay your fine at the court, there will be additional court costs and possibly a higher fine. Failure to respond on time could result in a fine of up to \$1000 and one year in jail and could also result in a warrant for your arrest.
2. **TO PLEAD GUILTY AND PAY YOUR FINE:**
 - a. **Complete and sign back of citation and return it with your payment.**
 - b. **Write your citation number and daytime phone number on the front of check or money order.**
 - c. Determine fine from back of page or by calling 877-866-3926 toll free for assistance. **Call if unsure.**
 - d. **DO NOT SEND CASH!** Send a check or money order (in U.S. dollars) **for full amount (no partial payments)** payable to **“Fine Collection Center”**. Use pre-addressed envelope you received or send to address above.
 - e. To pay by credit card, using either VISA or MasterCard, call toll free 877-866-3926 or go on the Internet to www.mofcc.com (there is a \$4 surcharge for phone and Internet payments).
3. **TO PLEAD NOT GUILTY:**
 - a. **Complete and sign the form below and send the signed form and your citation (or a copy)** to the Fine Collection Center. If possible, use the pre-addressed envelope or you may **fax** the not guilty plea to **573-522-8504**.
 - b. The Center will forward your citation to the county prosecuting attorney.
 - c. The court for the county where the violation occurred will notify you by mail of your court date.
 - d. **Note:** The court is not bound by the Fine Collection Center fine schedule and may assess additional costs and a higher fine.

REMINDERS – Read before paying your citation

1. **Payments:** Sign back of citation and return citation (or a copy), write citation number and daytime phone number on front of check or money order and make payment (in U.S. Dollars) to: Fine Collection Center. Call 877-866-3926 (toll free) or go on the Internet to www.mofcc.com to pay by VISA or MasterCard (\$4 surcharge on phone/Internet payments).
2. **Additional Court Costs in Certain Counties:** You must add the amount below to the total amount due listed for your offense if you received your citation in the following counties. The name of the county is found at the top of your citation or you may call the number listed above for assistance.
