6. Be a law abiding citizen of your community.



## **WHAT IS AN EVENING REPORTING CENTER?**

---

An Evening Reporting Center is a community based alternative to secure detention. It is meant to be a short term program which provides support, supervision, educational and therapeutic programs in a structured environment for the purpose of maintaining youth in the community.

## **SERVICES TO BE PROVIDED BY THE INTERSECTION:**

---

Youth who are referred to The Intersection as an Evening Reporting Center sanction will be provided supervision, tutoring/assistance with school homework assignments, programming, recreation, and a hot meal. The All Stars curriculum or other similar teen classes on positive life choices and resistance skills will be the majority of programming provided. Other classes provided by The Intersection include: cooking, drama, event planning, heroes and financial literacy. The Intersection will provide services from 3:00 p.m. to 6:30 p.m. Monday through Friday, except major holidays. Youth will be required to sign-in upon arrival. The attendance record will be maintained by The Intersection and will be provided to the Boone County Juvenile Office on a daily basis. A deputy juvenile officer will be assigned to visit the Evening Reporting Center daily to check attendance as well as meet with youth and handle problems as they might arise.

## **THE INTERSECTION – BEHAVIOR POLICY**

---

The purpose of this policy is to define expectations of behavior, encourage good character choices, create a safe environment for everyone and provide consequences for unacceptable behaviors at The Intersection.

I commit to the following as a member of The Intersection community:

- 1. I will show respect to myself and others by:* Greeting and responding to others with politeness. Using appropriate language for all ages. (Avoiding all profanity.) Show courtesy and good manners to others by saying “please”, “thank you” and addressing older adults as “ma’am” and “sir” as appropriate. Speaking in ways that affirm my value and dignity and that of others. Following instructions from program staff and appropriate adult volunteers. Dealing with conflict quickly and respectfully with the appropriate person.
- 2. I will develop and practice consideration for others by:* Looking out for the interests of others, as well as my own. Avoiding offensive language such as sarcasm, sexual humor or insults. Setting a positive example for others as a self disciplined, caring person. Assuming the best of others and asking for clarification where needed.

## **THE INTERSECTION – BEHAVIOR POLICY – CONTINUED**

- 3. I will be a responsible member of my community by:* Leaving any area or property in similar or better condition than I found it. Staying out of “Off Limits areas” inside and outside the building. Completing my half hour of homework within the first hour at the center or go home without argument.
- 4. I will practice planning and goal setting by:* Using a full half hour daily to improve my academic skills. Work with a program staff member to establish goals for the semester. Manage my Merit Bank account to be able to afford desired field trips.
- 5. I will contribute to The Intersection community by:* Providing one half hour of service each week to the community. Participating at community service and fundraising events. Participating in planning and performing one major event per year.
- 6. I will engage with learning by participating fully in educational, recreational and service opportunities as demonstrated by:* Attending the offered classes. Completing my homework time cooperatively and expediently. Attending and participating in Asset Meetings at 5:00 p.m. daily or go home. Participating in extra-curricular Community Service projects quarterly.
