- ___ Applicant is charged with Trafficking drugs in the first or second degree, or Sale of controlled substance within 1,000 feet of a school, or Possession of controlled substance with intent to distribute, deliver or sale
- ___ Applicant is charged with three or more felony counts
- ___ Applicant is currently under felony probation or parole supervision
- ___ Applicant has been found guilty for any degree of murder, voluntary or involuntary manslaughter
- ___ Applicant has been found guilty of a misdemeanor or felony sexual offense
- ___ Applicant has one or more prior felony convictions
- ___ Applicant has been found guilty of any degree of Robbery, Felony Assault a Weapons offense, or Armed Criminal Action
- ___ Applicant has history of assaultive or violent behavior
- ___ Applicant has been found guilty of two or more misdemeanor assaults
- ___ Applicant has been found guilty of Stalking or Violation of a Protective Order, or a domestic violence misdemeanor assault
- ___ Applicant has another pending criminal case on which he/she would be deemed ineligible
- ___ Applicant possessed amounts of outside the guidelines set forth on reverse side
