I agree to enter the DWI Court Program, and by doing so I understand I will have certain obligations and responsibilities. I will have to follow the directives given to me by the Judge, DWI Court Coordinator, tracker, and other treatment providers involved in the program. I further understand that information gathered during the program may be used for research purposes and follow-up.

## CLIENT RESPONSIBILITIES

### MY RESPONSIBILITIES ARE:

1. I will not use or possess any drugs or alcohol.
2. I will not enter establishments whose primary function is the sale of alcohol or gambling.
3. I will attend all required meetings.
4. I will be on time to appointments with treatment and DWI Court.
5. I will not make threats toward other participants or staff or act in a violent manner.
6. I will dress appropriately for court and appointments.
7. I will always tell the truth.
8. I must get permission from the Court before I leave Boone County.
9. I will turn in all required verification paperwork one (1) day prior to court.
10. I will report for drug and alcohol testing upon contact with law enforcement.
11. If restitution is owed, I must pay this amount in full as ordered by the court before completing this program.
12. I understand that I must follow the treatment plan and remain drug free. If I fail to do so, the DWI Court may impose additional conditions upon me which can include but are not limited to:
  - a. Warning from Judge
  - b. Move to end of the docket
  - c. Increase in court appearances
  - d. Additional community services
  - e. Increase reporting to tracker or DWI Court Coordinator
  - f. More frequent drug Court testing
  - g. Move back to previous phase
  - h. Spend time in Reality House
  - i. Spend time in jail
  - j. Electronic Monitoring
  - k. Set a curfew
  - l. Termination from DWI Court

I agree to sign all authorizations for release of information requested by the DWI Court Team and/or treatment providers and/or any other resource provider. I understand if the release of information that I sign is revoked I will no longer be eligible to participate in the DWI Court Program.

I waive any right I might have to representation by an attorney at DWI Court appearances.

I consent to a search of my person, residence, vehicles and any other property under my control by any representative of the DWI Court Team or any law enforcement officer.

I waive any rights I may have to a hearing on the issue of whether or not I am to be terminated from the DWI Court Program and I further waive any rights I may have to appeal in the event I am terminated from the DWI Court Program and understand and consent to the DWI Court Team being the sole authorities for determining such dismissal. On the issue of my termination from DWI Court, I agree to abide by the decision made by the DWI Court Team.

I FURTHER UNDERSTAND THAT IF I AM TERMINATED FROM THE PROGRAM IT MAY RESULT IN A PROBATION VIOLATION REPORT BEING FILED WITH THE COURT, A SUBSEQUENT HEARING BEFORE THE ORIGINAL SENTENCING JUDGE, AND POSSIBLE REVOCATION OF MY PROBATION AND EXECUTION OF THE ORIGINAL SENTENCE.

At the time of executing this document, I am of sound mind and body and I am not under the influence of any substance. The decision to waive my rights and enter the DWI Court Program is mine alone and made of my own free will. All of my questions about the DWI Court Program have been fully answered.
