Which Cognitive Behavioral intervention staff is qualified to deliver: All counselors that will serve treatment court consumers are trained in MRT, MI, CBT, the 12 Steps, and Dialectical Behavior Therapy (DBT). Counselors will be trained in any intervention utilized.
