IN RE: COVID-19 – Courthouse and Juvenile Office Premises *Administrative Order 20A0-05* 

## **ORDER**

**WHEREAS** the Supreme Court of Missouri has instructed courts in this state to post an order to the courthouse doors prohibiting access to the premises for individuals that have been exposed to or are exhibiting symptoms of COVID-19;

**IT IS HEREBY ORDERED,** effective Monday, March 16, 2020, until further order of this Court, that the following persons shall not enter the Audrain County Courthouse, the Montgomery County Courthouse, the Warren County Courthouse, or any Juvenile Office facility within the 12<sup>th</sup> Circuit:

- Persons who have tested positive, been diagnosed with, or have had contact with, anyone who has been diagnosed with COVID-19;
- Persons with fevers, or unexplained coughs or shortness of breath;
- Persons who have been asked to self-quarantine by any doctor, hospital or health agency;
- Persons who have traveled to any foreign county within the last 14 days; and
- Persons who reside or have had close contact with someone who has traveled to any foreign country within the last 14 days;

Anyone attempting to enter in violation of these protocols will be denied entry and removed from the Courthouse by Court Security.

Any attorney or party shall immediately notify opposing counsel and the court if they reasonably suspect that a participant in any proceeding authorized to be held by this Court's Administrative Order 20AO-04 may come within any of the above listed categories.

If you have a scheduled appointment or you are otherwise required to appear at one of the offices or divisions of these courthouses, and you are unable to appear because of the restrictions listed above, you should proceed as follows:
