Your application for probation has been received and approved by the Court. You are hereby placed on probation and advised that under the law the Court may at any time revoke or modify the conditions of your probation and that you are be subject to arrest upon order of the Court. STANDARD CONDITIONS OF PROBATION

1. LAWS: Probationer is required to obey all federal and state laws, as well as all municipal and county ordinances.
2. FEES: Probationer is responsible for paying a probation fee each month of their supervision, if on supervised probation.
3. TRAVEL: If on supervised probation Probationer will obtain advance permission from their PO before leaving their state of residence.
4. RESIDENCY: Probationer will notify PO, or the Court if there is no PO, of any changes in residency within 48 hours.
5. EMPLOYMENT: If supervised by a PO or the Prosecuting Attorney's Office, Probationer will maintain full time employment unless they have been granted permission not to be so employed. Probationer will obtain advanced permission from their PO before quitting any employment.
6. ASSOCIATION: Advance permission from PO is required prior to association with any person convicted of or on probation for a felony. In addition, PO is authorized to order that Probationer not associate with any person(s) and/or to impose conditions for such association.
7. DRUGS: Probationer will not possess or use any controlled substance except as prescribed by a licensed medical practitioner.
8. REPORTING: Probationer will report as ordered by PO. And report new arrests/charges or changes in job/program status within 48 hours.
9. SUPERVISION STRATEGY: Probationer will enter and successfully complete any supervision strategy ordered by their PO. Probationer will abide by all rules and program requirements as directed by their PO.
10. COSTS: Probationer is required to pay court costs in addition to Recoupment in the amount of: \$_____, both as a condition of probation.
11. RESTITUTION: Probationer required to execute a payment agreement with the Prosecuting Attorney's Office within 24 hours and abide by the conditions thereof. Restitution is set at \$_____[] payments limited to \$_____ per month; first payment due _____.
12. TIMELINESS: All conditions of probation are to be completed within 30 days unless otherwise specified. For programs that last longer than 30 days, Probationer is required to register for said program(s) within 30 days and complete them in a timely fashion thereafter.
