10. Describe the nature and extent of your experience as a practicing attorney in the trial and appellate courts, and explain how such experience demonstrates the quality of your legal work.

I have been a lawyer for more than twenty-five years. I have represented clients in municipal, state, and federal courts in multiple jurisdictions. I have both prosecuted and defended everything from speeding tickets to murder cases. I have represented corporations in civil cases and a homeless man accused of neglecting his children after the family was found squatting in an abandoned house. More recently, I have served as an associate circuit judge, presiding over cases in Family Court.

I began my legal career as a law clerk, where I was responsible for reviewing pleadings, researching issues, discussing the law and the facts with the judge, and drafting proposed orders and judgments for his review. I learned to prepare civil and criminal jury instructions. I benefitted from watching several trials conducted not only by the judge I worked for, but because he was the presiding judge, visiting and senior judges, too. They mentored me by explaining what made trial attorneys effective or not. I got to watch how the judges interacted with staff, attorneys, and jurors. I saw how to run an efficient and effective courtroom.

I have twice served Jackson County as an assistant prosecuting attorney. I was initially assigned to the Independence office, where I worked at the Warrant Desk, in the Drug Unit, and as the Jackson County Drug Task Force prosecutor. I later transferred to the Kansas City office, where I was a community prosecutor assigned to Kansas City Police Department Central Patrol Division. As a community prosecutor, I not only maintained a case load but also served as a liaison between the prosecutor's office and the community. I represented the prosecutor's office at meetings with business organizations and neighborhood groups. After returning to

the prosecutor's office in 2021, I was assigned to the Violent Crimes Unit, where I handled cases of homicide and other serious crimes of violence. During both stints in the prosecutor's office, I tried several cases, both as a first chair and a second chair.

After my first turn in the prosecutor's office, I worked as an associate attorney for an insurance defense firm. While I did not get to go to trial on any of my cases during the approximately three years I was with the firm, I did gain valuable knowledge about the practice of civil law by handling all other tasks related to civil litigation, including motion practice and hearings, written discovery, depositions, client and witness interviews and testimony preparation, drafting and defending summary judgment motions, and representing clients during mediation. The firm's clients included physicians, hospitals, trucking companies, and a multi-state convenience store chain. I assisted with cases representing all of these.

I eventually left the civil firm to start my own firm, specializing in criminal defense. There, I represented clients being investigated for or charged with criminal offenses in municipal, state, and federal courts in Missouri and Kansas. I handled everything from traffic infractions in small rural courts to drafting writ petitions in the United State Supreme Court. I was also appointed by federal judges to represent defendants in death penalty cases in both the trial and appellate courts. After maintaining my practice for nearly sixteen years, I returned to the Jackson County Prosecutor's Office, as described above.

In February 2025, Governor Michael Kehoe appointed me to fill the associate circuit judge vacancy in Division 30 of the Jackson County Circuit Court. I am currently on a two-year rotation to the Family Court, where I handle abuse and neglect, delinquency, status, and termination of parental rights cases. I also hear adoption petitions. In this position, I have gained invaluable experience hearing cases, managing dockets, and supervising a division staff.

While this summary of the nature and extent of my experience as a practicing attorney and an associate circuit judge may give some understanding of the quality of my legal work, I think it is better demonstrated by such things as judges who have watched me in their courtrooms then appointing me to represent people in death penalty cases where a sentence of life without parole is considered a win. It is shown in appellate briefs other lawyers asked me to help write or in their referrals of civil clients who got themselves accused of something. It is shown by my being selected to win the prosecutor's office's award for helping victims. And, finally, it is shown in the professionalism of the courtroom over which I currently preside.

It is these experiences that demonstrate the quality of my legal work, not simply appearing in courtrooms for a quarter of a century.

Throughout the course of my legal education and career, I have been fortunate to appear in front of or otherwise watch judges in several city, state, and federal courts in Missouri, Kansas, Illinois, and Texas. These experiences have shown me what a good judge looks like.

Similarly, I had the opportunity early in my career to work as a law clerk for the Honorable John R. O'Malley, a Jackson County circuit judge. Judge O'Malley

stressed the importance of being a person of good character when representing parties in the courtroom. He even converted a "No Smoking" sign to a "No Lying" sign that he displayed on the bench. We had several conversations about the importance of judges, attorneys, and staff being people of integrity, so jurors, witnesses, victims, and others interacting with the court system knew that the system would treat them justly, regardless of who won a particular case. Judge O'Malley was particularly protective of the concept of the jury trial, demonstrating his belief that having a jury of one's peers is the most important safeguard a party has in our court system. He always did his best to ensure that the voir dire process was not manipulated to exclude particular classes of people.

In a system where justice frequently has one side winning and the other side losing, it is important that the system be fair. It is a judge's responsibility to provide that sense of fairness in the system. As an associate circuit judge, I daily do my best to be mindful of the lessons Judge O'Malley taught me and to emulate the characteristics of the good judges I have seen during my career, so the parties appearing in front of me know that, even if they do not prevail in the courtroom, they have been fairly heard.

Additionally, over the course of the twenty-five years I have practiced law, I have become more empathetic. In criminal cases, I represented victims and their families as well as defendants and their families. In civil cases, I represented injured people and the corporations compelled to defend against their claims. Now on the bench in Family Court, I am given the authority to separate children from their families, a power not to be exercised frivolously. One cannot have these experiences without learning compassion for all whom the court system touches.

Finally, the breadth of my experience provides me the legal knowledge and ability to do the job of being a circuit judge. Throughout my career as a litigator and more recently in the role of an associate circuit judge, I have demonstrated an aptitude for considering issues, applying the law to the facts of a case, and communicating findings in a clear and concise way, whether in the courtroom or in writing. I am fully prepared to do the job of circuit judge.
