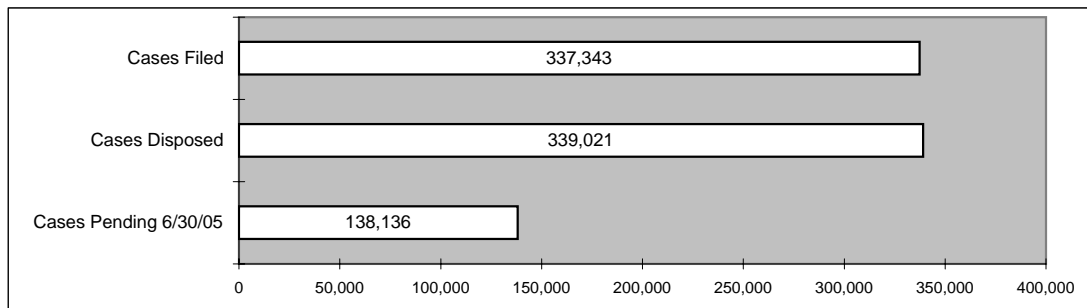

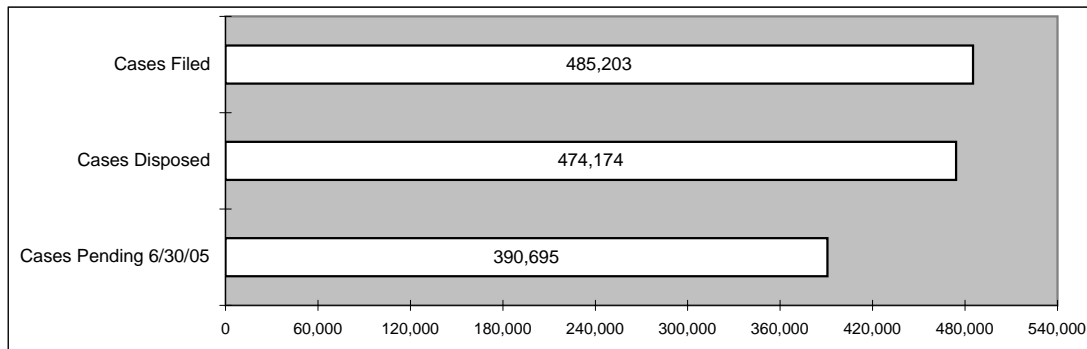

Statewide Totals

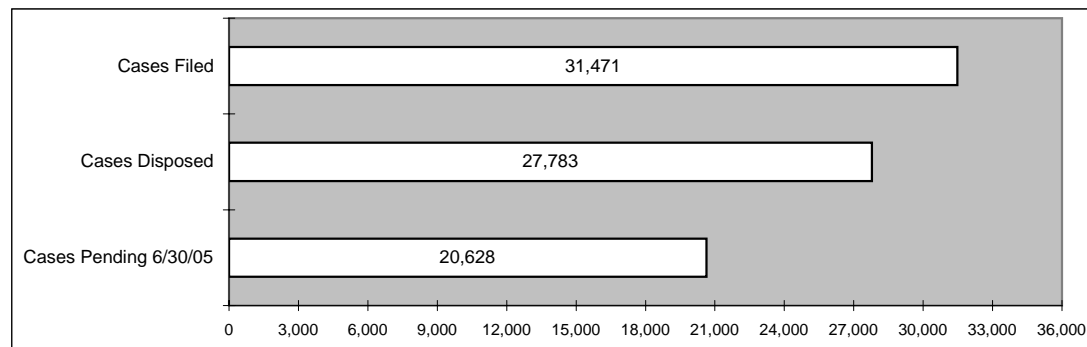
