## Summary of SC94101, In re the Marriage of: M.S. v. D.S.

**Overview:** A circuit court dismissed, for lack of subject-matter jurisdiction, a petition to dissolve a same-sex marriage. In a unanimous decision written by Judge Richard B. Teitelman, the Supreme Court of Missouri – without reaching or deciding any other issues – reverses the judgment and remands (sends back) the case because the state constitution grants the circuit court jurisdiction over civil matters such as dissolution petitions.

**Facts:** This appeal arises from the circuit court's judgment dismissing, on its own motion, a petition seeking to dissolve a same-sex marriage, on the grounds that it lacked subject-matter jurisdiction.

## REVERSED AND REMANDED.

Court en banc holds: The constitution gives the circuit court subject-matter jurisdiction. Article V, section 14 of the Missouri Constitution provides that Missouri circuit courts have jurisdiction over all civil cases and matters. Nothing in article I, section 33 of the Missouri Constitution purports to limit this grant of jurisdiction. A petition for dissolution of marriage is a civil case or matter falling within the circuit court's jurisdiction. This Court expresses no opinion as to the merits of any other aspect of this case, including the circuit court's constitutional authority to dissolve a same-sex marriage.
