## **Definition of Abuse**

You are notified that, under Section 455.501(1) RSMo, the term "abuse" includes any physical injury, sexual abuse, or emotional abuse inflicted on a child, other than by accidental means, by an adult household member or the stalking of a child. Discipline, including spanking, administered in a reasonable manner shall not be construed to be abuse.

## **Definition of Stalking**

You are notified that, under Section 455.501(10) RSMo, "stalking" occurs when an adult purposely and repeatedly engages in an unwanted course of conduct that would cause alarm to a reasonable person. "An unwanted course of conduct" is behavior that serves no legitimate purpose. Such conduct may include following a person or unwanted communication or contact. "Repeated" means two or more incidents that show a continuity of purpose, in other words, that are intended to cause alarm. "Alarm" means fear of physical harm.
