During my active years in Mound City Bar Association, I have served on the Pipeline to Success Committee and participated in the M.C.B.A. Mentoring Program. To this day, I maintain mentoring relationships with some of the young attorneys with whom I was paired. Through my affiliation with BAMSL, I volunteered for the holiday parties for youth with incarcerated parents. I have served as a presenter and judge for mock trials conducted at the high school and collegiate level. I have also served as a panelist for various organizations whose outreach focuses underserved on populations. Until recently, each Thanksgiving morning my family and I volunteered to feed unhoused and indigent individuals. Most recently, I was selected for Louisiana State University's Family Council, to serve as a liaison between LSU's leadership, students, and families.

I have always found fulfillment in serving youth and young adults. After spending over a decade helping high school students prepare for and apply for college, in 2022 I created a service that provides individualized assistance to high school students with the college application process, at no cost to the families I serve. I assist the students with composing their personal statement, researching admissions requirements for colleges of interest,

preparing their college application(s), and identifying and applying for scholarships to make college more attainable. Many of the students I have worked with over the years have graduated from college, and some have pursued graduate degrees. Throughout the process, I also try to impart words of wisdom upon the students about student loans, responsibly managing credit card debt, and other aspects of financial literacy that impact many college students years after graduating.

I have provided a Litigation Addendum to this application. Many of the cases on the Addendum arose from uninformed decisions I made at an early age, out of financial hardship and a lack of financial literacy. It should be noted that these cases arose from a set of facts that existed prior to me attending law school. My decision to attend law school was based, in part, on my determination to support my family financially and otherwise. As a result of these experiences, I have a unique perspective from the bench that allows me to be empathetic while making decisions that uphold the law.

As a municipal judge for the City of St. Louis, I am on the bench five days a week. I regularly preside over bulk dockets that range from 50 to 300 cases on any given day. Most of the individuals on these dockets are not represented by counsel. Further, many of the litigants are distrustful of the judicial system and/or do not understand the judicial process. I pride myself on ensuring that each individual is aware of their rights in municipal court, understands the court process, and is treated with dignity, regardless of the charge(s) before the Court. My tenure as a municipal judge has given me extensive experience in maintaining order and decorum in the courtroom, managing people in the courtroom, and developing systems and procedures to efficiently manage bulk dockets, all while maintaining Missouri Supreme Court minimum operating standards for municipal judges. My role as a municipal judge affords me the opportunity to collaborate with the Municipal Court Administrator and fellow municipal judges to evaluate and develop court policies and procedures that ultimately impact litigants and City residents.

When I am not on the bench, I am litigating cases involving abuse and neglect of minor children, in St. Louis County Juvenile Court. As a contract attorney, I may be appointed to serve as guardian ad litem for the minor child(ren), as guardian ad litem for a parent, or as counsel for a parent. In each capacity, I represent the individual and/or their interest in protective custody hearings, adjudication and disposition hearings, permanency hearings, adoption proceedings, termination of parental rights, and guardianship proceedings.

I also have years of quasi-judicial experience serving as an administrative hearing officer for the Parking Division of the City of St. Louis. In this capacity, I have conducted in-person and virtual hearings with individuals who wished to contest parking violations issued by the City of St. Louis and St. Louis Metropolitan Police Department. Upon conducting each hearing, examining evidence, and reviewing City parking ordinances, I prepared written findings of fact, conclusions of law, and determinations of liability or non-liability.

My experience as a practicing attorney, guardian ad litem, and municipal judge uniquely qualify me for judicial opportunities at the next level. My years at the Public Defender's Office, and subsequent years as a contract attorney for the Public Defender's Office, have equipped me with criminal litigation and trial experience. I have years of experience practicing family law, serving as a Guardian ad Litem, and conducting trials in Family Court. I have experience with complex civil litigation, having drafted and argued dispositive pre-trial motions and wrongful death settlement hearings in tort litigation and contract cases. Finally, I have experience managing the courtroom, and am acutely aware of the impact my decisions as a judge have on public safety, the city, and its residents.
