

# Petition for Removal of Unlawful Occupant of Property Containing a Residential Dwelling

County, Missouri Circuit Court (County where court is located. City of Saint Louis is considered a county.)

Use this form to ask for a court Order to remove a person or persons unlawfully occupying property containing a residential dwelling. This form is to be filed in the county where the property is located.

(Your Name) Petitioner,

You are the **Petitioner**. The Petitioner is the person who starts a court case. This person is the property owner, or an authorized agent of a property owner, of property containing a residential dwelling being unlawfully occupied.

And

Respondent.

Check this box if more than one person is unlawfully occupying the residential dwelling and complete an Addendum for each person.

The **Respondent** is the person or persons unlawfully occupying property containing a residential dwelling owned by Petitioner. Unlawful occupant or unlawful occupants is any person or persons who detain, occupy, or trespass on property containing a residential dwelling without the permission of the property owner, who otherwise have no legal right to occupy the property and have no protections provided to a tenant under state law.

## A. Parties
