My private practice of the Law was concentrated in the areas of Criminal Defense and Family Law at the Trial and Appellate levels. It has been my privilege to practice not only in St. Louis City and County but also in several Circuit and Associate Circuit Courts throughout the Eastern District of Missouri. Several of my cases have been adjudicated both formally and informally in the Juvenile Court in Saint Charles County, Saint Louis County and the City of Saint Louis. Several cases have been concluded before Agencies and Administrative Law Judges in and around the state. It has been my honor also to practice in the Federal System at both the District Court and Appellate levels, and I was previously admitted to the Bar of the Supreme Court of the United States.

While those matters concluded by trial during the last five years of my private practice are listed above, this does not include the several matters in both

the Criminal, and Family Law areas which during the last five years of my private practice as well as prior to that time, were fully prepared for trial but were concluded by a plea of guilty or other settlement. Of course such preparation includes the taking of many depositions and the conduct of evidentiary and other pre-trial hearings. Of the approximately fifteen cases that I have tried to conclusion before a jury, in my career, each and all of them were concluded with an acquittal or a verdict of guilty to a lesser offense than the one charged. One, civil case resulted in a verdict for the Plaintiff (against my client.). It would be difficult to count accurately, the number of Administrative Hearings concerning Missouri Driving Privileges that I have tried before an associate circuit judge, or a commissioner-many. Further it would be very difficult to calculate with precision the number of misdemeanor and felony criminal cases which were concluded without any charges being filed or in the alternative by the dismissal of the action or disposition by negotiated plea. Without question the most complex litigation that I handled in private practice concerned those cases in which the state sought capital punishment. These cases required the ability to handle multiple actions in different courts simultaneously and to fully coordinate their interaction to the client's benefit. One such case extended for nine years. In conclusion I can say without reservation that I have had great opportunities in my private practice of law and I have enjoyed the privilege of practicing law.

During the past eight years, I have been fortunate to serve as an Associate Circuit Court Judge in Saint Louis County. For the first nine months of that term I handled a Civil and Equity docket. In that assignment, I presided over six trials before a Jury and ninety-two trials to the Court. Thereafter, I was assigned to the associate criminal docket that averaged 480 cases. The Criminal docket includes daily confined and call dockets, bond hearings, bond forfeiture hearings and Probation Revocation Hearings and Preliminary Hearings concerning all criminal offenses—as well as Jury and Court tried cases concerning misdemeanors, traffic misdemeanors and infractions. In addition, I have been responsible for the municipal certification docket which averages 360 active cases. In that assignment I presided over six jury trials and twenty three trials before the court in the two year assignment. By assignment of the Circuit Court, Presiding Judge, I also handled felony pleas.

Following my assignment to the Criminal Division I was assigned to the Family Court for the years 2011 and 2012. During that two year term we disposed of/heard or determined 4,500 total matters, and disposed of more than 65 matters by trial or hearing (excluding trials regarding Orders of Protection.). My most recent assignment is again in the civil division and is as stated above. Of the matters concluded by trial during my eight years on the bench in all assignments several have been appealed. Thus far, the greater majority of those have been affirmed.

Appellate Decisions

1. Pleasant Hollow Homeowners Association v. Sun Ye Webster, et.al., ED91822, June 2, 2009, Action to Quash Sheriffs Sale, and set aside sale of real property valued between \$110,000.00 and \$160,000.00 for \$10.00. Trial Court set aside the Sheriff's sale, Affirmed by the Court of Appeals.

2. Frederick J. Peet, Jr., v. Dupont Securities Group, Inc., et., al. ED92802, November 24, 2009. Action to set aside a default judgment on the grounds of res judicata and collateral estoppel. Trial Court denied motion to set aside the judgment, Affirmed by the Court of Appeals.

3. Jeffrey A. Lerner v. Lori J. Teitjen, ED92486, August 17, 2009. Action to challenge the administrative findings of the Missouri Department of Social Services. Appeal Dismissed, after settlement of the parties.

4. Supplemental Medical Services, v. Medi Plex Health Care, ED91732, September 22, 2009. Action on Account and for Breach of Contract. The Trial Court found in favor of Supplemental Medical Services. The Judgment was Affirmed by the Court of Appeals, and Remanded for a Hearing on the issue of attorney's fees.

5. Timothy Schleeper v. Hon. Mary Ott and City of Creve Coeur, ED96075, January 4, 2011. This was a Writ action to challenge dismissal of the Defendant's Municipal action de novo in the trial court. Dismissed by the Court of Appeals.

6. City of Bridgton v. Kenneth Yarbrough, ED95092, April 19, 2011. Following a bench trial, the trial court found the defendant guilty of failure to follow the command of a law enforcement officer. Affirmed by the Court of Appeals.

7. State of Missouri v. Michael B. McCauley, ED94753, September 6, 2011. Appeal from the judgment upon defendant's conviction by a jury for sexual misconduct for which Defendant was sentenced by the trial court to one year in the St. Louis County Department of Justice Services. Affirmed by the Court of Appeals.

8. City of Creve Coeur v. Mary Nottebrok, ED96396, October 25, 2011. Constitutional challenge to the utilization by the City of Creve Coeur of Red Light Camera devices. Trial court found the defendant guilty of the municipal violation. Affirmed by the Court of Appeals.

9. St. Louis Association of Realtors v. City of Ferguson, SC91640, October 25, 2011. Constitutional challenge to City ordinance. Trial court found Association had no standing. Affirmed by Court of Appeals, and Reversed and Remanded by the Supreme Court of Missouri.
