I have spent my entire legal career as a litigator. I have a true passion for the pursuit of justice and for ensuring that all people have access to the judicial system and are treated fairly within it. The path of my work as a lawyer leads directly to a position as a judge.

I went to law school after being inspired by my parents' commitment to serving others in their careers. During the first year of law school I felt moved to assist victims of the 1993 flood in St. Louis and joined the volunteer effort coordinated through Legal Services of Eastern Missouri ("LSEM"). I then interned as a law clerk at LSEM during my first summer and was immediately entrusted to represent individuals in their appeals hearings for disability benefits before Social Security Administration Administrative Law Judges. I welcomed the responsibility, thrived with the work but knew that I wanted to end up practicing law in the courtroom. I have been doing that ever since.

My first trial was a jury trial in St. Louis County Circuit Court and came just months after being sworn in as a lawyer. I excelled at handling complex, catastrophic injury cases. I quickly earned a reputation for diligence, for excellent research and legal writing and for being able to spot and develop key issues in significant cases. I continued to handle jury trials on my own while also working with partners at the firm on complicated cases. I substantially contributed to cases that yielded the largest verdicts in Missouri in both 2000 and 2001 and several cases with the top settlement values. I was the principal author of an appellate brief that reversed summary judgment and ultimately resulted in a record verdict. I was routinely given the responsibility of coordinating experts on myriad issues in complex product liability cases. I was often primarily responsible for crafting legal theories, developing the facts to support them and then participating in trials. I also incorporated pro bono work

into my private practice by handling some housing and consumer cases for LSEM.

I switched gears in my career in 2005 after personal experiences pushed me toward helping more low-income people meet their basic survival needs. I believed that my experience and the skills I developed in my earlier practice could contribute to Legal Services of Eastern Missouri's mission to provide high-quality representation for the indigent population in eastern Missouri. I was fortunate to be able to volunteer almost full-time for several months. In that capacity I handled a variety of matters including housing cases, domestic violence cases, consumer cases and immigration matters. I was a quick study and was soon hired as a Staff Attorney in the Lasting Solutions Program. There I was able to exclusively represent survivors of domestic violence in family court cases such as orders of protection, divorces, custody and paternity cases.

In less than three years at LSEM I was promoted to the Managing Attorney position for the Lasting Solutions Program. The responsibilities are great in this unit that handles the largest volume of cases at LSEM. I manage a staff of attorneys, a social worker, paralegals and volunteers. Along with the considerable management responsibilities, I review all of the intakes and triage all of the emergency cases coming in to Lasting Solutions and maintain a heavy caseload of my own. Many of these cases are contested and present a wide variety of procedural and evidentiary issues. I am constantly in court trying cases, negotiating custody and support orders or arguing motions. These are significant cases where success often means safety and long-term stability.

Because we cannot meet the great need for our services, I have dedicated myself to reaching out beyond our paid staff for assistance. I have provided training to hundreds of potential volunteer attorneys in private practice so that they may competently represent domestic violence survivors in family court. Further, since becoming the Managing Attorney, I have recruited, trained, mentored and supervised more than 17 lawyers who work and have worked as in-house volunteer attorneys with the Lasting Solutions Program. Each year I present at several continuing legal education ("CLE") events to both train and encourage pro bono work. I also helped to establish a system to engage volunteers in the St. Louis County Domestic Violence Court since its inception in 2010. In 2015, I was appointed as the Co-Chair of the Pro Bono Committee of the Bar Association of Metropolitan St. Louis.

In 2009, the Missouri Supreme Court appointed me to Missouri's Child Support Guidelines Review Subcommittee. I served on this committee with other attorneys, judges and family court commissioners in excess of four years where we reviewed and recommended revisions of the child support guidelines to the Family Court Committee of the Missouri Supreme Court. I was then asked to serve as an Advisory Member to the Family Court Committee (which consists only of members of the judiciary) as it formulated its official recommendations on child support guidelines revisions to the Missouri Supreme Court.

It is at LSEM where I have done my best work as a lawyer. I do not measure the quality of my legal work by the great outcomes in court that I have been able to achieve or other successes I have enjoyed. Rather, the success is in what my clients

are able to accomplish with the strong foundation those outcomes provide. Many of my clients are living lives free of violence as they become able to provide safe, stable homes for their children. Many are able to realize their dreams of finishing school or establishing a career. Most have reclaimed their voice, their control and their sense of hope and freedom.

20. Describe your community activities, including any organizations, not listed above, with which you are affiliated:

I am employed as a public interest lawyer representing low-income victims of domestic violence. A large part of my work outside of the courtroom is spent engaging with the community to help educate about domestic violence and work toward its prevention. I have been an Advisory Committee member for the St. Louis Family Violence Council, and active in many other area domestic violence groups. On several occasions I have presented to non-attorney advocates and laypeople about the legal rights of survivors of domestic violence. I have also spoken at area community colleges on parental rights and related legal issues.

In 2014 I joined the Board of Directors for Annie's Hope - the Bereavement Center for Kids. This nonprofit organization provides comprehensive grief support services for children, teens and their families. In December 2014 I was elected to the office of Secretary of this active board.

I also regularly volunteer for the veterans' clinic at the Veteran Administration's Hope Recovery Center in the city of St. Louis. In 2013 the Missouri Bar began a pilot project for attorneys to meet with veterans to provide advice on a range of legal issues. I have participated in these clinics and outreach efforts since the project began.

I have coached some of my children's sports teams including my oldest son's soccer teams for 3 years, his baseball team for three years and my daughter's soccer team for two years. I am a member of St. Luke the Evangelist Catholic Church where my children and I attend regularly.

When I graduated law school in 1996, I received two awards from the faculty of the Washington University School of Law. First was the Order of Barristers for demonstrating excellent advocacy skills. The next was the Pro Bono Bronze Medal for my commitment to helping others and promoting pro bono work in law school.

In 1996 I co-authored the chapter on “Voir Dire and Jury Selection” of the Civil Trial Practice “Deskbook” published by the Missouri Bar.

In 2009 received the “Up and Coming Lawyer” award from the Missouri Lawyers Weekly. According to the Lawyers Weekly, Up and Coming Awards “recognize legal professionals 40 or younger, or within the first 10 years of practice, who fulfill both of the following criteria: (1) demonstrate a level of professional accomplishment, skill and leadership beyond their years, and (2) demonstrate an extraordinary commitment to the community through their volunteer service and leadership.”

In its inaugural year of 2010, I was nominated for and accepted into the Theodore McMillan American Inn of Court as a Barrister. The American Inns of Court are devoted to improving the skills, professionalism and ethics of attorneys and judges.

In 2012 I co-authored the article “Representing Survivors of Domestic Violence in Order of Protection Cases in Missouri” that was published in the fall 2012 St. Louis Bar Journal (volume 59, number 2). The Bar Association of Metropolitan St. Louis publishes the St. Louis Bar Journal. With the assistance of another attorney, I also coordinated the remaining articles and authors for this issue.

Since 2008, I have developed a number of written materials that are designed to train potential volunteer attorneys on how to handle order of protection cases for survivors of domestic violence. The materials educate on the legal issues, the related ethical responsibilities and provide practical advice for effectively handling these cases.
