A. I have been honored to serve since January, 2014 as a Family Court Commissioner in St. Louis County. My docket is domestic cases. I handle dissolutions, paternity and child custody and support actions, domestic violence cases, motions to modify and motions for contempt. Since assuming the position of Commissioner, I have presided over thirteen multi-day trials ranging from two to seven days and over another forty-five one day trials. This is in addition to weekly dockets of adult abuse and child order of protection hearings, motion hearings and non-contested hearings.

See attached **Addendum A** for ten significant cases which I have presided over to completion.

B: In 2009 when I became the Director of Health and Senior Services, I had to close my practice, so there is not a five year window prior to my becoming a commissioner. See attached **Addendum B** for a representative sample of cases which I tried throughout my career.

Member of the Missouri Legislature

During my six years in the legislature I constantly analyzed and wrote legislation. There were fewer than 20 lawyers out of the 163 members of the House of Representatives and as a result the lawyer members were often called upon to assist with drafting and review of legislative proposals in a broad range of areas. I was a member of varied committees. At times I was the only lawyer member. As a legislator participating as "the sausage was made", I gained valuable perspective on statutory construction and interpretation. As a practicing attorney as well as a legislator, I was very conscious of how essential it was that we strive for precision and clarity as we crafted language for a bill.

Department Director, Department of Health and Senior Services

As the head of both the state public health agency and the state office on aging, I oversaw and was responsible for multiple statutorily created programs, including responding to disasters, regulating health care institutions and providing protective services to the elderly and disabled. On a daily basis, I met the challenge of implementing policy within the constraints of statutes and rules. I frequently testified before legislative committees about department operations. Making technical information accurate and understandable was an essential part of my responsibilities. It is a skill I call upon now in writing orders and judgments.

Local Government

Serving on a school board and the local transit agency, I participated in decisions on a variety of issues impacted by education and local governmental law. I developed a knowledge base in both areas.

Law School Teaching

In teaching as the Health Policy Scholar in Residence and as an adjunct faculty at Saint Louis University Law School, I co-taught a health policy seminar and worked with the health law faculty across the health law curriculum to connect health law course content with current issues, legislation and litigation in the public sector. Additionally, I focused on developing students' advocacy skills and proficiency in making clear, cogent arguments.

My primary volunteer activities were serving as a volunteer in the public sector. I was a member of the Ferguson-Florissant Board of Education and a member of the METRO Board of Commissioner. In 1990, then County Executive Buzz Westfall asked me to serve as Chair of the Commission for Abused Women and Children which he had created. The Commission provided the leadership in establishing the first domestic violence shelter in St. Louis County.

In the non-profit world I previously served on the board of Ecumenical Housing Production Corporation (now known as Beyond Housing) whose mission is to provide safe affordable housing and the community services that are needed to stabilize neighborhoods. Additionally, I was a board member of Family Support Network, (now part of Epworth Family and Children's Services) which provides counseling and parenting support to families at risk of child abuse and neglect.

I participated in Leadership St. Louis, a year-long program whose goal is to educate leaders from all sectors about the challenges facing the St. Louis region and to better prepare them to respond to the community's needs.

When I entered the legal profession, I believed the law not only provided the way for individuals to resolve their specific problems, but also offered important and effective remedies to influence the larger issues of justice in our society. My professional life reflects those two paths.

Every day as a Family Court Commissioner, I witness individuals whose fate is placed in the legal system and I am reminded of the heavy responsibility borne by the judiciary in maintaining trust in that system. What happens in our courthouses will influence—for good or ill—how individuals view not only their particular case but also our democratic institutions.

Since joining the Court, I have become a member of the Budget Committee and of the Strategic Planning Committee for our Circuit. I am serving on the Family and Domestic Violence Council and was recently appointed co-chair of the Firearms Committee of the council which is working in cooperation with local law enforcement on the most effective ways to reduce the risk of firearms in domestic violence cases. I also participate in a committee looking at the effective use of Parent Coordinators in the Family Court. Having served in the other two branches of government I believe I can play a helpful role in fostering relationships with public officials in the other branches and in working on issues which impact the operation of the judicial system. The Circuit Judge position is a further opportunity to serve the public and the justice system.
