Treatment Court Program Status


As of April 30, 2013, there were 132 treatment court programs: 90 adult, 7 juvenile, 12 family, 18 designated DWI, 1 reintegration, and 4 veterans courts serving 12 counties. The commission provided funding to 49 treatment court jurisdictions that include 126 treatment court programs.

Participants

As of April 30, 2013, there were 3,567 individuals participating in treatment courts as measured by a count of cases. The adult category includes reintegration, veterans, and adult drug courts unless otherwise noted.


Total Participant Trend




Admissions

There were 175 admissions to treatment courts during this reporting period as measured by a count of cases. The number of admissions for calendar 2013 is 821. Re-entry also includes reintegration case types.

As of April 30, 2013, there have been a total of 12,740 treatment court graduates.

A total of 655 babies have been born to female participants during treatment. **600 of these have been born drug free.**

- Three drug free babies were born to participants that exited treatment court during this reporting period.
- No drug exposed babies were born to participants that exited treatment court during this reporting period.

Note: Current period plus prior period calendar year totals may not equal the current calendar year totals due to cases that were added after reports for the prior period were run.
