Treatment Court Program Status


As of Aug. 31, 2014, there were 136 treatment court programs in 43 judicial circuits: 90 adult, 9 juvenile, 12 family, 19 designated DWI and 6 veterans courts serving 28 counties. The commission provides funding to 115 of these programs in 41 judicial circuits.

Participants

During the month of August there were 3,729 individuals participating in treatment courts as measured by a count of cases. The adult category includes veterans and adult drug courts unless otherwise noted.


Total Participant Trend




Admissions

There were 155 admissions to treatment courts during this reporting period as measured by a count of cases. The number of admissions for calendar 2014 was 1,668.

- The average age at admission was nearly 34 years old.
- Admissions ranged in age from 18 to 67 years old.

Termination includes termination and voluntary withdrawal docket types.

As of Aug. 31, 2014, there have been a total of 14,745 treatment court graduates.

A total of 713 babies have been born to female participants during treatment. **659 of these have been born drug free.**

- Two drug free babies were born to participants that exited treatment court during this reporting period.
- No drug exposed babies were born to participants that exited treatment court during this reporting period.

Note: Current period plus prior period calendar year totals may not equal the current calendar year totals due to cases that were added after reports for the prior period were run.
