

# Drug Courts Coordinating Commission


## Treatment Court Program Status

As of 6/30/2010 there were 123 operational treatment courts: 80 adult, 17 juvenile, 13 family, 3 reintegration and 10 designated DWI. The commission provided funding to 53 treatment court jurisdictions that include 118 operational treatment courts.

### Participants

As of 6/30/2010 3022 individuals were participating in treatment courts as measured by a count of cases. The adult category includes reintegration, DWI and adult drug courts unless otherwise noted.




### Admissions

There were 151 admissions to treatment courts during this reporting period, as measured by a count of cases, bringing the total number of admissions for the calendar year to 1,089. Re-entry also includes reintegration case types.

- The average age at admission was nearly 31.
- Admissions range in age from 18 to 59.

**Exits**

Termination includes termination, voluntary withdrawal, administrative discharge and dismissal docket types.

As of 6/30/2010 there have been a total of 9185 treatment court graduates.

A total of 513 babies have ever been born to female participants during treatment. **469 of these have been born drug free.**

- 1 drug-free baby was born to participants that exited treatment court during this reporting period.
- No drug-exposed babies were born to participants that exited treatment court during this reporting period.

Note: Current period plus prior period Y-T-D totals will not necessarily equal the Y-T-D totals for this period, due to cases being added after the reports for the prior period were run.
