

# Drug Courts Coordinating Commission

## Treatment Court Program Status


As of June 30, 2013, there were 132 treatment court programs: 90 adult, 7 juvenile, 12 family, 18 designated DWI, 1 reintegration, and 4 veterans courts serving 12 counties. The commission provided funding to 49 treatment court jurisdictions that include 126 treatment court programs.

### Participants

As of June 30, 2013, there were 3,484 individuals participating in treatment courts as measured by a count of cases. The adult category includes reintegration, veterans, and adult drug courts unless otherwise noted.


Total Participant Trend




### Admissions

There were 186 admissions to treatment courts during this reporting period as measured by a count of cases. The number of admissions for calendar 2013 is 1251. Re-entry also includes reintegration case types.

As of June 30, 2013, there have been a total of 13,033 treatment court graduates.

A total of 661 babies have been born to female participants during treatment. **606 of these have been born drug free.**

- Three drug free babies were born to participants that exited treatment court during this reporting period.
- No drug exposed babies were born to participants that exited treatment court during this reporting period.

Note: Current period plus prior period calendar year totals may not equal the current calendar year totals due to cases that were added after reports for the prior period were run.
