Treatment Court Program Status


As of November 30, 2014, there were 137 treatment court programs in 43 judicial circuits: 90 adult, 9 juvenile, 12 family, 20 designated DWI and 6 veterans courts serving 28 counties. The commission provides funding to 130 of these programs in 42 judicial circuits.

Participants

During the month of November there were 3,784 individuals participating in treatment courts as measured by a count of cases. The adult category includes veterans and adult drug courts unless otherwise noted.

Total Participant Trend




Admissions


There were 154 admissions to treatment courts during this reporting period as measured by a count of cases. The number of admissions for calendar 2014 was 2,381.

- Admissions ranged in age from 15 to 75 years old.

Termination includes termination and voluntary withdrawal docket types.

As of November 30, 2014, there have been a total of 15,169 treatment court graduates.

A total of 733 babies have been born to female participants during treatment. **677 of these have been born drug free.**

- Six drug free babies were born to participants that exited treatment court during this reporting period.
- No drug exposed baby was born to participants that exited treatment court during this reporting period.

Note: Current period plus prior period calendar year totals may not equal the current calendar year totals due to cases that were added after reports for the prior period were run.
