"Never Underestimate the Power of a Determined Woman with a Briefcase"

My Dad told me I could do anything. So when I changed my academic path from journalism to law, he assured me I would succeed. As I began my career, I powered forward like the little engine that could... "I think I can, I think I can."

My first challenge was joining a Kansas City law firm known for its expertise in Sports Law. The firm had never promoted a woman to partner in its one-hundred and twelve-year history. I powered through that glass ceiling to not only become the firm's first woman partner, but to also become a Managing Partner. Swanson, Midgley offered challenging trial and appellate opportunities with sophisticated clients such as the NCAA, the Veterans of Foreign Wars, and Yellow Freight.

After almost twenty years of intense trial and appellate work at Swanson Midgley, I voluntarily resigned my partnership to practice law with my husband, a solo practitioner in the Northland of Kansas City. This acquainted me with the local bench and bar of Clay and Platte Counties and educated me to the unique challenges of a small law practice.

After ten years, the little engine began to rev again. I wanted to be a Judge. However, Platte County had never appointed a female judge. With determination and loyal supporters, I once again powered through a glass ceiling. My judicial assignments required that I learn both criminal and juvenile law, in addition to utilizing my civil practice experience. In my first retention election, I received one of the top five composite scores in the state from the lawyers that appeared before me. On a scale of 1 to 5, with 5 being the highest, I ranked among the top in the state in "maintaining a professional demeanor in the courtroom" (4.83); "the judge was prepared for court" (4.71); "the judge listened carefully during the court proceeding" (4.79); and "the judge addressed individuals (e.g., attorneys, court staff, litigants, public, witnesses) respectfully in the courtroom" (4.83).

In my thirty-three-year career, I have experienced the practice of law from a metropolitan law firm, a solo practice, and the trial bench. I have been fortunate to encounter almost every area of law that would be reviewed by an appellate court. This diversity of experience has strongly prepared me for the review and analysis required by an appellate judge.

My participation in this case began following an adverse determination for the NCAA by the United States Tax Court. I prepared the brief and formulated the argument which caused the United States Court of Appeals for the Tenth Circuit to reverse the determination by the United States Tax Court. The issue before the Court was whether the promotional notices appearing in the NCAA's program for the Men's Final Four Basketball Tournament generated unrelated business taxable income. The Internal Revenue Service was so upset by the opinion, they placed the following exception in the Regulations related to unrelated business taxable Income (IRC§ 512(b)(2)).

IRS won't acquiesce in the 10th Cir. holding in National Collegiate
Athletic Assn., above. IRS asserted that time span of advertising
activity should include time soliciting and preparing

advertisements for publication, and so disagreed with 10th Cir. conclusion that preparatory time shouldn't be considered. (AOD 91-015, 7/3/91)

Although the IRS issued the above statement regarding the outcome of this case, it chose not to appeal the case to the United States Supreme Court. Several years after the Tenth Circuit determination, we received a call from the IRS Office in Washington DC. Bruce R. Ellison was retiring and we were told that this case was his greatest frustration. They asked if we could send them something from the case that they could use at his "Retirement Roast"; we sent them the original Final Four Basketball Program that was marked as an exhibit in the case. Ellison later authored two books on unrelated business taxable income and prominently referenced this case in both. The case has been cited to the U.S. Supreme Court and has a huge impact in the non-profit world, particularly in the sports area. It is one of the reasons that we no longer have college bowls games named the "Fiesta Bowl" but now have the "Doritos Fiesta Bowl".

This case was initiated by our client, general contractor Carlund Corporation, who filed a mechanic's lien alleging non-payment for participation in a cathodic protection project in the Crown Center Hotel Parking Garage. Cathodic protection is used in reinforced concrete structures, such as large parking garages, to slow the corrosion of the rebar in the steel. The process requires laborious saw cutting in the floor of the structure for electronic ribbons to be buried which send currents to the rebar to impede its corrosion. The initial proceeding was a two-week jury trial. There was also a successful Writ of Prohibition proceeding initiated by our client at the Western District Court of Appeals against the trial judge in the midst of the case. There was an additional appeal to the Western District on an issue by a secured lender for Carlund that claimed a right to intercept payments to Carlund's subcontractors. The O'Hara brothers were painting in an attic when an explosion caused life-threatening injuries to John and severe burns to both John and Michael. The trial resulted in a total disability determination for John and partial disability determination for Michael. Due to an alleged lapse in the insurance policy for non-payment of premiums by the employer, there were significant legal issues in the case, in addition to the nature and extend of the Claimants' injuries.

(c). Judicial Experience:

I was appointed to Associate Circuit Judge in January of 2014 and have served in that capacity to the present date. My judicial assignments include felony criminal proceedings, domestic relations, and juvenile cases.

In criminal cases, I am responsible for the case from arraignment through preliminary hearing. I have also been assigned some of the criminal proceedings from our Presiding Judge to handle through final disposition. One such case was State of Missouri v. Scott A. Gilbert, Case #123AE-CR01233-01. This case was one of longest criminal jury trials in the history of Platte County, and generated 71 Jury Instructions and 46 Verdict Forms. Mr. Gilbert was found guilty of 10 felony counts and was sentenced to 128 years in prison. The case was affirmed on appeal by the Western District Court of Appeals, WD 79322 (2017). Additionally, as part of my criminal assignment, I review requests for warrants on a daily basis and review requests for search warrants several times a week.

In domestic relations matters, I handle marital dissolution, modification, and other child custody cases. In addition, I handle emergency orders of protections for adults, and as the juvenile judge, exclusively handle child orders of protection. It is not unusual for me to have three domestic relations bench trials a week, in addition to my regular criminal, juvenile and adult abuse dockets. I handle domestic matters from the date of filing to disposition by trial or settlement. I preside over all temporary order proceedings and other pre-trial proceedings; conduct discovery conferences; and determine all post-trial motions, including review of Qualified Domestic Relations Orders.

Upon the retirement of former Presiding Judge Lee Hull, I was honored to accept the appointment as Juvenile Judge for Platte County in February 2014. I have a docket for juvenile matters twice a month, but it is not unusual for me to hear juvenile matters several times a week, due to their urgent nature. I am exclusively responsible for all juvenile proceedings and am continuously on call to address juvenile matters. I preside over all juvenile abuse and neglect matters from initial protective custody proceedings, through all review and permanency hearings, to final disposition, at times requiring termination of parental rights trials. I am also exclusively responsible for all delinquency cases for juveniles in Platte County.

As Juvenile Judge, I also have exclusive jurisdiction over all adoption proceedings in Platte County, from initial filing to final disposition, including review of all studies and evaluations prior to making determinations on both initial and final placements.

While I was an Associate at Swanson, Midgley, one of our Partners served as a Missouri Bar Examiner. I was assigned the task of grading bar exam essays. The creativity demonstrated by some of the exam candidates enlightened me to look beyond the obvious response and think "outside the box". This experience gave me the confidence to trust my own creative intuition when analyzing legal issues. Now as a "seasoned" lawyer, that experience continues to remind me to utilize creativity in approaching complex legal issues.

I also enjoy mentoring law students. I have accepted law students from the University of Missouri School of Law for internships over the semester breaks. I provide the students with observation opportunities not only in my courtroom and chambers, but also throughout the courthouse. I am in the process of locating a student from the University of Missouri – Kansas City to serve as a law clerk for our entire circuit.

I was a presenter at CLE's when in private practice and have served on several judicial panels for CLE's and other presentations since taking the bench. In 2019, I will be a Presenter at the Missouri Judicial Colleges on the Issue of the National Immigrant Women's Advocacy Project. I was nominated for membership on the Missouri Team for this Project. I have attended one national training session on these issues, and will attend another in April of 2019, allowing me to assist Missouri judges in recognizing these issues, including human trafficking, when confronted with them in our courtrooms.

I have been a victim of violent crime and endured the horror of one of my daughters being the victim of a violent attack. My experience was in 1989 when I was the victim of a "bump and rob" on the highway driving home late from the office. Thankfully, due in part to boxing lessons I had received from my older brothers, I was able to keep the attacker out of my car and escaped with only a bloodied face and torn clothing. The same perpetrator killed a woman just two nights after my attack. In my daughter's encounter, she and her boyfriend were attacked by a gang in St. Louis in broad daylight. Her injuries required surgery to repair. The St. Louis Police were familiar with the style of attack and characterized it as a "gang initiation". These life experiences allow me to empathize with victims of violent crimes. Such empathy has been valuable as a trial judge and will also enhance my ability to evaluate criminal proceedings presented on appeal.
