I was admitted to the Missouri Bar in September, 1984. My license is in good standing.

I also am licensed in: the State of Kansas; the Federal District Courts for the Western and Eastern Districts of Missouri, and the District of Kansas; and the United States Courts of Appeals for the Eighth, Tenth, and Eleventh Circuits.

I attended the University of Missouri, Columbia, Missouri from 1977-1981. I received a BJ in Journalism and an AB with Honors in Economics.

I attended the University of Missouri School of Law, Columbia, Missouri, from 1981-1984. I received my JD degree in May, 1984.

I was the Editor in Chief of the Missouri Law Review for the 1983-1984 school year. I was on the Dean's List for academic achievement during each semester of law school. I was a member of the Delta Theta Phi law fraternity.

During my undergraduate studies, I was employed by KFRU Radio in Columbia, Missouri as a reporter/announcer; I worked as a teaching assistant in the Economics Department; and I worked as a teaching assistant at KBIA Radio in the Journalism School. During law school, I worked at KOMU-TV in Columbia, Missouri as a sports

reporter and news anchor. I was employed as a summer law clerk at the Watkins, Boulware, Lucas & Miner law firm in St. Joseph, Missouri following my first year of law school. I worked as a summer law clerk at the Stinson, Mag & Fizzell law firm in Kansas City, Missouri following my second year of law school.

From July, 1984 to September, 1986, I worked as a law clerk for the Honorable Joseph E. Stevens, Jr. at the United States District Court for the Western District of Missouri, Kansas City, Missouri. From October, 1986 to November, 1991 I was employed as an associate at the law firm of Stinson, Mag & Fizzell in Kansas City, Missouri. From November, 1991 to December, 1993 I was an associate with the law firm of Nygaard & Associates in Overland Park, Kansas. From January, 1994 to October, 1996 I was a partner in the law firm of Nygaard & Miller, Overland Park, Kansas.

From October, 1996 to June, 2006, I practiced law as the Law Firm of John J. Miller, P.C. My office was located at 132nd and Metcalf in Overland Park, Kansas from 1996 until September, 2001, and thereafter was located at 4770 North Belleview, Kansas City, Missouri.

In June, 2006, I joined the law firm of Swanson Midgley, LLC, Kansas City, Missouri, as a non-equity member of the firm. On January 1, 2007 I became an equity member of the firm, and on January 1, 2008 I was elected as one of three members of the firm's Executive Committee. I served on the Committee until December 31, 2012. I continue to practice today with Swanson Midgley, and our office is located at 4600 Madison, Suite 1100, Kansas City, Missouri 64112.

I have been in the private practice of law for more than 25 years, and I believe my practice has been unusually diverse. I've served as a federal court law clerk, worked in one of the largest law firms in Missouri, worked for two smaller firms, and I've practiced on my own. Although my practice in recent years has emphasized securities and commercial litigation, during my career I've represented clients in virtually every type of matter, including domestic, criminal, estate, antitrust, and patent infringement. I have represented both plaintiffs and defendants, which have ranged from Fortune 500 companies to indigents. I have achieved seven-figure recoveries for my clients, and I've successfully defended other clients against multi-million dollar claims.

As lead counsel, I have tried a half-dozen jury trials, at least two-dozen bench trials, and more than 50 securities and commercial arbitrations. I've served as co-counsel in numerous other trials and arbitrations. I have testified as an expert witness in legal malpractice matters, served as a private arbitrator, and been selected as a neutral mediator on multiple occasions. I believe the broad scope of my practice, and the research, writing, and oral advocacy my practice has required, would serve me well as a member of

the judiciary.

At the appellate level, I have either been lead counsel or participated actively in cases before the United States Courts of Appeals for the Eighth, Tenth and Eleventh Circuits, the Missouri Court of Appeals, the Kansas Supreme Court, and the Kansas Court of Appeals. The following is a sample of my recent appellate work, in reverse chronological order:

1. *Seaboard Corp. v. Marsh, Inc.*, 295 Kan. 384, 284 P.3d 314 (2012). I served as co-counsel for the Marsh company defendants on interlocutory appeal of the Johnson County District Court's denial of Defendants' motion to dismiss. Plaintiff was represented by Patrick Stueve, Stueve, Siegel & Hanson, Kansas City, Missouri. I participated in preparation of Defendants' brief but did not argue the cause.

2. *Packard v. Credit Solutions of America, Inc.*, 42 Kan.App.2d 382, 213 P.3d 437 (2009). I represented Credit Solutions on appeal of the Wyandotte County District Court's denial of Credit Solutions' motion to compel arbitration of a commercial contract dispute. Mr. and Mrs. Packard were represented by Donald Huelson, Olathe, Kansas. I prepared Appellant's brief, which I have submitted with my application, but I did not argue the cause.

3. *Riley v. United States*, 486 F.3d 1030 (8th Cir. 2007). I represented Mr. Riley in his appeal of the Eastern District of Missouri's dismissal of his Federal Tort Claims Act suit. The United States was represented by the Office of the United States Attorney, St. Louis, Missouri. I participated actively with my co-counsel in preparation of Appellant's brief but did not argue the cause.

4. *United States Beef Corp. v. Genuik & Labor and Industrial Relations Commission*, 134 S.W.3d 83 (Mo. App. 2004). I represented United States Beef in its appeal of an adverse benefits decision by the Labor and Industrial Relations Commission. Alan Downs, Jefferson City, Missouri, represented the Commission. I participated in the preparation and filing of Appellant's brief.

5. *Sampson v. Biomat, Inc., et al.*, 77 P.3d 1009 (Kan. App. 2003). I represented Blaine and Margaret Sampson on appeal of the Johnson County District Court's entry of summary judgment in favor of Defendants on the Sampsons' claim for alleged violation of the Kansas Securities Act. Defendants were represented by Bill Sampson, Shook, Hardy & Bacon, Overland Park, Kansas. I prepared Appellant's brief, which I have submitted with my application, and I argued the cause.

6. *Hall v. Kansas Farm Bureau*, 274 Kan. 263, 50 P.3d 495 (2002). I represented Gary Hall, former President of the Kansas Farm Bureau ("KFB"), on appeal of the Riley County District Court's entry of summary judgment in favor of KFB on Hall's employment-related claims. KFB was represented by Edward Bailey, Topeka,

Kansas. Due to the unique nature of the claims presented, the Kansas Supreme Court directed transfer from the Kansas Court of Appeals prior to oral argument. I prepared Appellant's Brief, which is submitted with my application, and I argued the cause.

7. *Marcus v. Kansas Department of Revenue*, 170 F.3d 1305 (10th Cir. 2000). I represented Joel Marcus on appeal of the Kansas District Court's dismissal of Marcus' claim for alleged violations of the Americans with Disabilities Act. The Kansas Department of Revenue was represented by Brian Cox, Kansas Assistant Attorney General, Topeka, Kansas. The Tenth Circuit reversed the District Court's dismissal and remanded for further proceedings. I participated actively with co-counsel in preparation of Appellant's Brief but did not argue the cause.

8. *Sav-A-Trip, Inc. v. Belfort*, 164 F.3d 1137 (8th Cir. 1999). I represented Sav-A-Trip, Inc. on Respondents' appeal of the District Court's confirmation of a \$712,000.00 securities arbitration award in favor of Sav-A-Trip. Respondents were represented by Anthony Joseph Romano, Kansas City, Missouri. The Eighth Circuit affirmed the confirmation of the arbitration award. I participated actively with co-counsel in preparation of Appellant's Brief but did not argue the cause.

I have maintained an active, prominent practice in securities arbitration and litigation. I repeatedly have been recognized as one of the "Best Lawyers in America" and as a Missouri "Super Lawyer" for my securities practice. I have served as lead counsel in securities matters in at least 11 states, and I have achieved substantial awards or settlements from every major Wall Street firm. I primarily represent investors in claims against brokerage firms and financial advisors, though I also represent brokerage firms and individual advisors. Although most of my matters are resolved by private, confidential settlements, the following are a few of my recent, publicly-reported cases, in reverse chronological order:

Securities Arbitration:

1. *Mirabelli v. Merrill Lynch, Pierce, Fenner & Smith, Inc.*, Financial Industry Regulatory Authority Case No. 10-3400. I served as co-counsel for former major league baseball catcher Doug Mirabelli and his wife Kristin in this Michigan arbitration against Merrill Lynch for alleged misrepresentations in the sale of unsuitable retirement investments. Merrill Lynch was represented by attorneys from the Dorsey & Whitney law firm. Following three weeks of hearing held over four months, the arbitrators in January, 2012 awarded my clients \$800,219.00 in compensatory damages, more than \$70,000.00 in interest, \$391,474.00 in attorneys' fees, and \$47,339.91 in costs.

2. *Horn v. Dayspring Investment Group, Inc.*, Financial Industry Regulatory Authority Case No. 10-0247. I represented the estate of Garland Horn in this Oklahoma arbitration against Mrs. Horn's financial advisor for alleged unsuitable retirement

investments. Gary Haney of Seymour, Missouri represented Dayspring. After hearing in November, 2010, the arbitrator awarded my client \$62,286.63 in compensatory damages.

3. *Halfmann v. VFinance Investments, Inc.*, Financial Industry Regulatory Authority Case No. 08-0472. I represented Donald and Patricia Halfmann in this Missouri arbitration against their financial advisory firm for alleged theft of funds from their retirement accounts, and for other alleged misconduct. VFinance was represented by Adam Smith of Boca Raton, Florida. Following a three-day hearing in August, 2009, the arbitrators awarded my clients \$259,802.66 in compensatory damages, more than \$45,000.00 in interest, \$400,000.00 in punitive damages, and \$100,000.00 in attorneys' fees.

4. *Routh, et al., v. Barber, et al.*, Financial Industry Regulatory Authority Case No. 07-02704. I represented Steve and Christy Routh in this Kansas arbitration against their financial advisors for alleged unsuitable retirement investments. The advisors were represented by a Milwaukee, Wisconsin law firm and by Faegre & Benson, Des Moines, Iowa. Following a three-day hearing in September, 2008, the arbitrators awarded my clients \$168,000.00 in actual damages.

5. *Boston v. Suiter, et al.*, National Association of Securities Dealers Case No. 05-6530. I represented John and Virginia Boston in this Missouri arbitration against their financial advisors for alleged unsuitable retirement investments. The advisors were represented by Donald Mehan, Moline, Shostak, & Mehan, St. Louis, Missouri. Following a three-day hearing in October, 2006, the arbitrators awarded my clients \$104,000.00 in compensatory damages and \$74,000.00 in punitive damages.

6. *Hopkins v. UMB Financial Services, Inc., et al.*, National Association of Securities Dealers Case No. 04-3756. I represented Dorothy Hopkins in this Missouri arbitration against her financial advisors for alleged improper securities sales. The advisors were represented by Perry Brandt, Bryan Cave LLP, Kansas City, Missouri. Following a four-day hearing in April, 2005, the arbitrators awarded my client \$61,032.00 in damages and \$17,250.00 in attorney's fees, with interest on these sums.

7. *DeShazo v. Edward D. Jones & Co., et al.*, National Association of Securities Dealers Case No. 03-5851. I represented Karen DeShazo in this Kansas arbitration against her financial advisors for alleged violations of Kansas' securities laws. The advisors were represented by in-house counsel for Edward Jones. Following a four-day hearing in December, 2004, the arbitrators awarded my client \$193,550.00 in damages.

Securities Litigation:

1. *Chaiet v. Allen, et al.*, United States District Court for the Western District of Missouri Case No. 05-cv-00725-ODS. I served as co-counsel for Plaintiff in this shareholder derivative action against the officers and directors of American Italian Pasta Company. Defendants were represented by several of the major law firms in Kansas City, Missouri. The case settled in December, 2008.

2. *CNBS, LLC v. Dougherty, et al.*, Johnson County, Kansas District Court 07CV02809. I represented CNBS, a Kansas City-area brokerage firm, in this 2007 injunctive relief action against two stockbrokers for alleged breaches of their non-compete agreements. Defendants were represented by John Shaw, Berkowitz, Oliver, et al., Kansas City, Missouri. The Court entered the requested injunctive relief in favor of CNBS.

3. *Bank of America Investment Services, Inc. v. Martin*, United States District Court for the Western District of Missouri Case No. 06-cv-00714-FJG, and *Bank of America Investment Services, Inc. v. Harrison*, Case No. 06-cv-0092-ODS. I served as co-counsel for Bank of America in these 2006 injunctive relief actions against two Kansas City-area stockbrokers for alleged breaches of their non-compete agreements. Defendants were represented by Richard Fritz, Kansas City, Missouri. Both actions settled during the injunction proceedings.

I also represent individuals and businesses in a broad variety of commercial litigation matters in federal and state courts. The following are some of my recent matters:

1. *Leggett & Platt, Inc. v. Healthstat, Inc.*, United States District Court for the Western District of Missouri, Case No. 12-5036-SW-JTM. I represented Healthstat in this breach of contract matter. Leggett & Platt was represented by the Lowther Johnson firm of Springfield, Missouri. The case settled in October, 2012 following mediation.

2. *Powell Gardens, Inc. v. N.W. Electric Power Cooperative & Dow Agrosciences, LLC*, Circuit Court of Johnson County, Missouri, Case No. 10JO-CV00690. I represented Powell Gardens in this matter regarding alleged property contamination from hazardous materials. N.W. Electric Power was represented by the Anderek Evans law firm of Smithville, Missouri, and Dow Agrosciences by Shook, Hardy & Bacon, Kansas City, Missouri. The case settled following mediation and acceptance of an offer of judgment in June, 2012.

3. *Children's Wish Foundation Int'l, Inc. v. Mayer Hoffman McCann, P.C.*, Circuit Court of Jackson County, Missouri, Case No. 0516-CV19973-01. I was hired as trial counsel by Children's Wish Foundation after the Missouri Supreme Court remanded this professional negligence case for a new trial. Defendants were represented by Stinson

Morrison Hecker LLP, Kansas City, Missouri. The case settled in February, 2012 following mediation.

4. *McLaughlin v. Rain Nutrition, LLC*, Circuit Court of Jackson County Missouri, Case No. 1016-CV25362. I served as co-counsel for Rain Nutrition in this breach of contract matter. Plaintiff was represented by Michael Gibbons, Kansas City, Missouri. In June, 2011, the Court granted Rain Nutrition's motion to compel arbitration and stayed the matter pending arbitration.

5. *Dealer Development Group Services, LLC v. Warrantech Automotive, Inc.*, Circuit Court of Jackson County, Missouri, Case No. 0916-CV24915. I served as co-counsel for Warrantech in this breach of contract matter. Plaintiff was represented by the Polsinelli Shughart firm, Kansas City, Missouri. The parties entered into a stipulated final injunction in December, 2009.

6. *Abrams v. McNeil, et al.*, Circuit Court of Jackson County, Missouri, Case No. 04CV228310-01. Following a December, 2008 bench trial, the Court entered judgment in favor of my client, Allan Abrams, on his claim for alleged breach of a settlement agreement, promissory note, and personal guaranty. The Court awarded all requested damages, including \$372,664.51 in actual damages and \$352,614.40 in interest. Defendants were represented by Richard Helfand, Kansas City, Missouri.

7. *L.G. Barcus & Sons, Inc. v. Faherty*, District Court of Wyandotte County, Kansas, Case No. 05CV314. I represented Defendant Bill Faherty in an August, 2008 bench trial of Plaintiff's claim for Faherty's alleged breach of the non-compete clause in his engineering employment agreement. L.G. Barcus, which was represented by Ryan Denk, Kansas City, Kansas, sought more than \$1,000,000.00 in liquidated and consequential damages from Faherty. The case settled during the third day of trial.

I've also represented clients in securities, insurance, and employment administrative proceedings before federal, state and local agencies, including the Commodities Futures Trading Commission, the Financial Industry Regulatory Authority, the Kansas Insurance and Securities Commissions, and the Missouri Insurance and Securities Commissions.

I am a court-approved mediator for the Missouri state courts, and for the United States District Courts for the Western District of Missouri and the District of Kansas. I have served as a mediator in several cases, including *Stoneman v. Bank of America Investment Services, Inc.*, United District Court for the Western District of Missouri, Case

No. 08-CV-00852-SOW, and *Erten v. BAC Home Loans Servicing, LP*, United States District Court for the Western District of Missouri, Case No. 10-CV-00640-HFS. I have served as an arbitrator for the Financial Industry Regulatory Authority and the American Arbitration Association. I have testified as an expert witness in two legal malpractice lawsuits, once on behalf of the defendant attorney, and once on behalf of the plaintiff.

I am the Securities Committee Chair for the Kansas City Metropolitan Bar Association, and I have held this position on multiple occasions. I am a member of the Johnson County, Kansas Bar Association. I'm a member of the Missouri Association of Trial Attorneys. I also am a member of the Public Investors Arbitration Bar Association ("PIABA"), which is a national association of attorneys that represent parties in securities arbitration. I have served on various PIABA committees over the past 20 years.

I have prepared written materials and given presentations at numerous continuing legal education programs sponsored by the Missouri Bar Association, the Kansas City Metropolitan Bar Association, the University of Missouri, the Kansas Bar Association, and the Public Investors Arbitration Bar Association, as well as programs sponsored by various businesses.

I have been an "av" rated attorney in Martindale Hubbell for more than a decade. I've been recognized as a Missouri "Super Lawyer" by that publication from 2007-2013. I've been named as one of the "Best Lawyers in America" by that publication in 2012 and 2013. I am a member of the Million Dollar Advocates Forum, which is an organization of trial attorneys that have achieved verdicts or settlements in excess of one million dollars.

I currently am a member of the Leadership Council at Platte Woods United Methodist Church, Platte Woods, Missouri. I have served in numerous positions at the Church over the past 25 years. I am a Past President of the Board of Trustees of the

I have held various volunteer positions with the local chapters of the United Way and the Juvenile Diabetes Research Foundation, and with Communities Creating Opportunity in Kansas City. I'm a member of the Mizzou Alumni Association, as well as the Association's Kansas City chapter. I'm a member and former officer and director of the Tiger Club of Kansas City. I coached my two daughters' basketball and softball teams for more than a decade, and I was a sponsor/instructor for the Chess Club at Oakhill.

I have never been sued by a client, nor have I had a client complaint. I have been a party defendant in the following two matters:

1. *Kearns v. Kumar, et al.*, Case No. 00-cv-00177-NKL, United States District Court for the Western District of Missouri, filed February, 2000. A stockbroker, whom I named as a defendant in a securities arbitration then pending before the National Association of Securities Dealers, filed this pro se lawsuit against my client in the arbitration, my co-counsel, and me, alleging he had been slandered in the arbitration proceedings. Plaintiff dismissed the lawsuit in June, 2000 upon the

settlement of the underlying arbitration. Neither the other defendants nor I was required to plead prior to dismissal of the lawsuit, nor did defendants make any payment to plaintiff.

2. *Bosilevac v. Pakel, et al.*, Case No. 95-cv-02314-KHV, United States District Court for the District of Kansas, filed July, 1995 and *Kramar v. Criticos, et al.*, Case No. 95CV08368, District Court of Johnson County, Kansas, filed July, 1995. The matters settled in early 1996 during the discovery stage.
