
Defendant Elementis LTP Inc. ("Elementis") hereby provides these suggestions informing the Court that Elementis has received notice of the filing of a voluntary bankruptcy petition by Wismo Chemical Corp. ("Wismo"), a defendant in this action. Upon information received to date, a bankruptcy petition was filed by Wismo seeking protection under Chapter 11 of the Bankruptcy Code. A true and accurate copy of the Wismo Bankruptcy Petition is attached hereto as Exhibit A. The case has been filed in the United States Bankruptcy Court for the District of Maine, Case No. 10-11952.

In addition, notices of the bankruptcy have been issued to potential creditors. See "Notice of Chapter 11 Bankruptcy Case, Meeting of Creditors and Deadlines," a true and accurate copy of which is attached hereto as Exhibit B.

Most recently, the bankruptcy court issued an "Order Directing Joint Administration of the Debtors' Chapter 11 Cases." A true and accurate copy of this order is attached as Exhibit C. Under this order, the Wismo case will be jointly administered with other cases, including the bankruptcy actions filed by Defendants Prime Tanning Co. Inc. and Prime Tanning Corp.


