#### **Annual Overview from the Jury Supervisor**

It has been quite an honor working as the Jury Supervisor for the 13<sup>th</sup> Circuit Court, and serving Boone and Callaway counties. This is my second year in this position, and I am excited to list achievements and improvements of better office policy and service for the public. For Callaway, we have a new office location in the Justice Center, which was commemorated on May 9, 2023. At this new venue, we have had a good opportunity to work with members of our community, which has aided in the development of policy to make their service more relaxed and comfortable. Both of our offices have had an improvement of policy retention, which came with the approval of the Jury Supervisor Reference Guide; a comprehensive tome of knowledge and experience for our future Jury Administrators. Lastly, this year we have begun developing a new policy, referred to as a Reminder Notice. When we ask Jurors to report for a Trial, we have the system send out Texts and Emails to those whom are being asked to report. This new policy has shown promise when reviewing attendance records. Absenteeism has decreased in Boone from 14 % in 2022, to 6% in 2023; and for Callaway it has decreased from 19% in 2022, 8% in 2023 – which is the best rating even when compared against this same category over the last 5 years.



Below, you will find statistics, presented for Boone and Callaway, all the way from the creation of the Jury Panel, down to the number of Jurors selected to hear a trial. It is our intention to preserve and present this data in transparency, for the best interest of the public.



#### Jury Service Boone County

Jury service in Boone County consists of a two-month term of service. If selected, individuals are assigned one week during that two-month term. They are assigned a juror number and asked to call or check online every evening during their assigned week to see if they are needed for jury service.

As shown below, 24,000 questionnaires were sent out to potential jurors in Boone County in 2023. Many jurors are disqualified, excused or deferred before actually being called to serve. For 2023, 9,925 individuals were assigned a week of service but only 3,097 were asked to report. The total number of individuals who actually served on a jury was 510. The 189 jurors who failed to report were either placed in a future term or asked to report to the courthouse and appear before a judge to state why they were unable to appear for jury service.

#### Jury Trial Statistics Boone County

2023 showed a significant increase of jury trials, doubling the number from previous years. Of the 41 jury trials held, there were 4 civil and 32 criminal verdicts returned. There was a total of 8 jury trials in the month of November 2023, making almost 20% of the yearly jury trials held in only 1 month. The increased number of trials in 2023 expanded our courtroom use, showing that 51% of all jury trials were heard in the Ceremonial courtroom, 44% being heard in 3 West, and 5% being heard in 1 West (1 West had not been used since 2016).



#### Jury Service Callaway County

Jury service in Callaway County consists of a threemonth term of service. If selected, individuals are assigned two weeks during the quarter. They are assigned a juror number and asked to call or check online every evening during that two-week period to see if they are needed for jury service.

As shown below, 7,000 questionnaires were sent out for qualifying potential jurors in 2023. Of the 7,000 questionnaires, 2,520 individuals were assigned a two-week term of service, but only 310 were actually asked to report. The total number of individuals that served on a jury was 41. The 24 jurors who failed to report were either placed in a future term or asked to report to the courthouse and appear before a judge to state why they were unable to appear for jury service.

#### Jury Trial Statistics Callaway County

During 2023, Callaway had under half the number of trials from the previous year. A point of interest, there were no civil jury trials heard in Callaway in 2023. Regarding the criminal trials heard in Callaway, all but 1 jury trial resulted in a verdict being rendered. Of the verdicts rendered in 2023, 100% returned a verdict of guilty. Of the 4 panels reporting in Callaway, 2 were in the month of April, making it the busiest month of the year. During April 2023, all of our jury activity fell within the weeks of 18-29, causing 43 jurors to return to the courthouse for a second panel.


#### **Jury Exit Questionnaires**

When individuals are called for jury service, it is important that they receive courteous, responsive, and respectful treatment. Exit Questionnaires were developed as a way to improve jury service throughout the 13<sup>th</sup> Judicial Circuit.

As jurors report for service, the Court Marshals and Jury Administration assist with checking attendance, preparing seating charts, and creating rosters for the judge and attorneys. After attendance has been verified, Deputy Marshals instruct panel members on how the day will proceed, the courtroom location and judge, and type of case they will be hearing that day. Those panel members assembled are presented with an Orientation Video, which provides a detailed overview of the jury selection process. During this orientation, jurors are informed of, and provided with, an Exit Questionnaire, which they may return confidentially. Panel members are then escorted into the courtroom to begin the selection process.

The following charts and data were compiled from data collected from answers indicated on all Exit Questionnaires returned for the year 2023. Certain categories\* indicate the percentage of Excellent or Good responses, out of the total 100% returned.
