1. Call to Order / Welcome

The meeting was called to order by Presiding Judge Brouck Jacobs at 5:00PM.

Judge Christopher Wilson moved to approve the Callaway Board of Jail Visitors. Seconded by Judge Ben Miller. The vote was unanimous to approve.

6. Election of Presiding Judge

Judge Brouck Jacobs announced it was time to have the voting for the next Presiding Judge for the 2025 – 2026 term. Judge Jeff Harris nominated Judge Josh Devine for Presiding Judge, seconded by Judge Ben Miller. Hearing no other nominations, Judge Brouck Jacobs called for a vote by secret ballot conducted by Judge Kimberly Shaw in Boone County and by Judge Christopher Wilson in Callaway County. After all ballots were cast and reviewed, the announcement was a unanimous vote for Judge Josh Devine.

Judge Brouck Jacobs moved that Judge Josh Devine assume the role of Presiding Judge effective immediately, seconded by Judge Jeff Harris, and an emergency vote was taken. The vote was unanimous to approve.

Judge Brouck Jacobs welcomed Judge Jayne Pearman to the Court En Banc.
