

**CONSENT TO PARTICIPATE IN THE IN-HOME DETENTION PROGRAM**

1. The juvenile is ordered to participate in the In-Home Detention Program.
- 2a. The juvenile will participate in the In-Home Detention Program with Voice Verification as arranged. This includes:
  - a. Ensuring that the telephone is free from any services such as call waiting, call forwarding, etc.
  - b. Receiving random daily telephone calls in which the juvenile must respond to the telephone within 30 seconds of the telephone ringing.
  - c. The juvenile speaking clearly into the telephone and ensuring that background noise, such as the television or radio, is kept to a minimum.
  - d. The juvenile keeping a log of times at which he/she was called by the Voice Verification System.
  - e. The juvenile and his/her family ensuring that no telephone calls are longer than 5 minutes in duration.
  - f. The juvenile and his/her family ensuring that there is a 20 minute period of time where the telephone is not in use in between telephone calls.
  - g. Upon receiving a call from Voice Verification you must then IMMEDIATELY call 1-866-733-0106 to complete the verification process.
- 2b. The juvenile will participate in the In-Home Detention Program with Electronic Monitoring as arranged. This includes:
  - a. Ensuring that the telephone is free from any services such as call waiting, call forwarding, etc.
  - b. The juvenile will have an electronic bracelet attached to his/her ankle.
  - c. The juvenile and his/her family ensuring that no telephone calls are longer than 5 minutes in duration.
3. The juvenile is restricted to home except for school, work, or activities as approved in advanced by the Juvenile Officer.
  - a. The juvenile is required to attend school daily when school is in session, unless excused by the Juvenile Officer.
4. The juvenile must telephone the Juvenile Officer upon return home from school, work, and approved activities. The telephone number to the Boone Juvenile Office is (573) 886-4200. The number for the Callaway Juvenile Office is (573) 826-2844
5. The juvenile and his/her family will submit to random surveillance checks the Juvenile Officer.
6. The juvenile will attend all Court appearances.
7. The juvenile’s parents will pay the amount listed below per day while the juvenile is on the Juvenile Officer’s In-Home Detention Program.
8. The juvenile will be detained at the Robert L. Perry Juvenile Justice Center if he/she fails to comply with any of the above conditions.
