Contract Amendment 002 OSCA 19-00284-13

The Office of State Courts Administrator (OSCA) hereby amends the above referenced contract. All other terms, conditions and provisions of the current contract period shall remain the same.

The amendment adds the following:

Section 2.0.10 If health restrictions or requirements are issued by either federal, state, county or local authorities, the contractor may provide contracted services, virtually and/or by telephone. The contractor may provide treatment services remotely during length of time the health restriction is authorized by authorities.
