13. Describe the nature and extent of your experience as a practicing attorney in the trial and appellate courts, and explain how such experience demonstrates the quality of your legal work.

The focus of my entire legal career has been in the courtroom where cases are tried. I made my first appearance in a trial prior to graduating from law school over 20 years ago. I appeared in the Circuit Court of Jackson County, Missouri as a Missouri Supreme Court Rule 13 Intern and successfully prosecuted an assault case. After graduation, Jackson County Prosecutor Claire McCaskill assigned me to prosecute cases generated by the Jackson County Drug Task Force. As a trial attorney there, I reviewed, filed and prosecuted more than 200 cases investigated by the Task Force. This is where I cut my teeth as a trial lawyer.

I further developed as a trial attorney after I became the trial team leader for the Domestic Violence Unit in the Jackson County Prosecutor's Office. In this position, I supervised other assistant prosecutors and was responsible for the prosecution of all crimes involving domestic abuse in the County. Shortly after my assignment to the Domestic Violence Unit, I was appointed to serve on the Homicide Committee. I worked with a committee of seasoned assistant prosecutors to review, file and try homicide cases. My work on the homicide committee brought me invaluable experience in determining when and how homicide cases should be filed and as lead counsel and second chair on numerous trials.

I continued to serve on the Homicide Committee while working in other positions within the Jackson County Prosecutor's Office, including Trial Team Leader for the

Independence Drug Unit and Chief Warrant Officer for Eastern Jackson County. In these positions, I continued trying cases while supervising other assistant prosecutors and staff responsible for reviewing, filing and prosecuting criminal cases. In 1999, I was named one of four Chief Trial Assistants for the Jackson County Prosecutor. As a Chief Trial Assistant, I served as lead counsel in many high profile cases while supervising and training other assistant prosecutors. I received the Louis Lombardo Prosecutor of the Year Award at this time.

In an effort to expand my trial knowledge and skills, I accepted a position as an associate with Armstrong Teasdale, LLP in their Litigation Department. While at Armstrong Teasdale, I practiced in the State and Federal courts in metropolitan Kansas City. I handled cases in areas such as personal injury, premises liability, securities fraud, commercial contracts, real estate, bankruptcy, collections, consumer fraud and criminal law.

After practicing in the civil arena for a time, I accepted the position of Deputy Prosecutor for Jackson County, Missouri in the hope I would eventually become the Jackson County Prosecutor. I attained that goal in 2007. As Prosecutor, I have made it a priority to continue to appear in trial and appellate courts representing the State of Missouri. I have maintained a docket of cases, trying many of our area's most recent high profile cases, including Precious Doe and Lorenzo Gilyard.

Over the course of my career I have made hundreds of filing decisions, taken and defended depositions, briefed and argued various motions both as plaintiff and defense counsel, tried cases to the bench and juries, briefed and argued post conviction motions and hearings in the trial courts, and briefed and argued direct appeals and extraordinary writs in the Missouri Court of Appeals. Throughout this time, I have gained an extensive amount of experience as a trial attorney, facing a wide array of issues I expect to face again if given the opportunity to serve on the bench.

The quality of my legal work is best demonstrated by the success I have enjoyed in my practice in the trial and appellate courts. Like many attorneys, I received the opportunity to participate in litigation after first earning the trust of others. I earned this trust by building a record of excellent legal work resulting in success in the majority of cases I litigated. In my experience, quality legal work comes from hard work, careful preparation and an extreme attention to detail. I have been fortunate to have been given

opportunities to practice in the courts on many different cases. These opportunities would not have been possible without my record and reputation of quality legal work.

State v. Justin Bennet, 0816-CR05557. Murder First Degree, Armed Criminal Action. Represented the State of Missouri. Jury Trial, November 9, 2009, Division 2, Judge Michael Manners. Guilty all counts, life without parole and life. Domestic violence case where defendant stabbed his estranged girlfriend 116 times.

State v. Harrell Johnson, 0576-CR02893. Murder First Degree. Represented the State of Missouri. Jury Trial, October 6, 2008, Division 14, Judge John Torrence. Guilty, life without parole. Child abuse case where the defendant kicked the victim Erica Green, formerly known to the community as Precious Doe, causing her death. Defendant allowed her condition to deteriorate and she died without obtaining medical care. After the victim died the defendant severed her head to hide her identity.

State v. Dwayne Jones, 0716-CR00897. Forcible Sodomy, Statutory Sodomy, Forcible Rape. Represented the State of Missouri. Jury trial, April 14, 2008, Division 70, Judge William Kramer. Guilty all counts, 20 years. Defendant abducted and raped a nine year old girl who was walking alone.

State v. Lorenzo Gilyard, 16CR-04002567. Six Counts of Murder First Degree. Represented the State of Missouri. Bench trial, March 5, 2007, Division 6, Judge John O'Malley. Guilty on five counts, life without parole on each count. Defendant was a serial murderer who killed five women.

State v. Adrian Washington, 0516-CR02421. Murder Second Degree, Armed Criminal Action. Represented the State of Missouri. Jury trial, October 9, 2007, Division 18, Judge Brian Wimes. Guilty all counts, life and 10 years. Defendant shot the victim in a gang related dispute over drug trafficking.

State v. Dejuan Thompson, 16CR-99005925. Robbery First Degree, Armed Criminal Action. Represented the State of Missouri. Jury trial, November 22, 2000, Division 6, Judge John O'Malley. Guilty on all counts, 30 years and 15 years. Defendant stalked and robbed the victim while she was attempting to enter her home.

State v. Derrick Jones, CR 99-04843. Murder Second Degree, Attempted Robbery, six counts of Kidnapping, eight counts of Armed Criminal Action. Represented the State of Missouri. Jury trial, Division 17, Judge C. William Kramer. Guilty, life on all counts. The defendant and two accomplices shot and killed the manager of a grocery store during the course of a robbery. The defendant took several employees hostage before being captured by the police.

State v. David W. White, CR98-05235. Murder Second Degree, Armed Criminal Action. Represented the State of Missouri. Jury trial, Division 17, Judge C. William Kramer. Guilty all counts, 30 years. Domestic violence case. The defendant shot his 18 year old girlfriend in a park in unincorporated Jackson County.

State v. James F. Whitfield, CR98-05533. Burglary First Degree, Armed Criminal Action, Robbery First Degree, Armed Criminal Action. Represented the State of Missouri. Jury trial, Division 16, Judge John I. Moran. Guilty on all counts, 15 years and 20 years. This case was a residential robbery while the victim was home with his six year old son.

State v. Randy Danikas, CR 97-02734. Murder First Degree, Armed Criminal Action. Represented the State of Missouri. Jury trial, Division 28, Judge Vernon Scoville. Guilty on all counts, life without parole and life. Domestic violence case where the defendant shot his wife. The case involved a great deal of forensic evidence to rebut the defense of accidental shooting.

State v. Billy G. Haddock, CR97-09017. Murder Second Degree. Represented the State of Missouri. Bench trial, Division 17, Judge C. William Kramer. Sentence 15 years for Voluntary Manslaughter. Domestic violence case where defendant strangled his wife. The only witness to the crime was the victim's three year old daughter.

State v. Antwain Washington, CR96-6036. Robbery First Degree, Armed Criminal Action. Represented the State of Missouri. Jury trial, Division 5, Judge Jack Gant. Guilty 30 years and life. This case involved an armed robbery of a Service Merchandise Store during business hours. The defendant and three co-defendants took \$120,000 worth of jewelry from the clerks at gunpoint and led police on a chase through residential areas.

State v. Jeremy Henke, CR96-6077B. Assault First. Represented State of Missouri. Jury trial January 6, 1997, Division 2, Judge Ely. Guilty, 13 years. Defendant attacked 88 year old man without any provocation.

State v. Angel Dequesne, CR95-6047. Murder Second Degree, Armed Criminal Action. Represented the State of Missouri. Jury trial, September 30, 1996, Division 1, Judge Shinn. Guilty on all counts, life and life. Defendant stabbed the victim during an argument.

State v. Michael Duncan, CR95-2185. Receiving Stolen Property, Possession of Auto Parts with Altered Identification Numbers. Represented the State of Missouri. Jury Trial, August 26, 1996, Division 16, Judge John I. Moran. Guilty all counts, 3 years and 2 years. Defendant operated large scale methamphetamine labs throughout Kansas City area. This

case was defendant's first conviction ending his criminal enterprise. He was subsequently convicted in Federal Court of drug charges.

State v. Lyonel Hardin, CR95-7552. Assault Third Degree. Represented the State of Missouri. Jury trial, Div. 10, July 29, 1996. Guilty, 90 Days. Domestic violence case where the victim testified against her long time abuser ending her cycle of violence.

State v. Brian S. Kelley, CR94-2826. Assault First Degree. Represented the State of Missouri. Jury trial, Division 16, Judge John I. Moran. Guilty, 25 years. The defendant's claim to fame was his ability to knock someone out with one punch. The defendant struck the victim, a stranger to him, on a dare and placed the victim in a coma for two weeks. The victim suffered severe brain damage requiring daily medical assistance for remainder of his life.

State v. Henry Rollie, CR94-5635. Trafficking Drugs First Degree. Represented the State of Missouri. Jury trial, December 12, 1995, Division 13, Judge Jay Daugherty. Guilty, 15 years. After receiving parole for the murder of a police officer, defendant sold cocaine.

State v. Larry L. Smith. CR93-1601. Sale of a Controlled Substance within 1000 feet of a School. Represented the State of Missouri. Jury trial, Division 16, Judge John I Moran. Guilty 10 years. Defendant sold drugs across the street from an elementary school.

There are many similarities between the responsibilities and duties of a Circuit Court Judge and my current position as Jackson County Prosecutor. The most significant of these similarities is prosecutors, like judges, are called upon to make extremely difficult decisions that will have a profound impact on people in our community.

Like judges, the role of the prosecutor goes beyond the role of advocating for an individual person or entity. Rather, we are charged with advocating for the best interests of our State and the community as a whole. We often see the worst side of our society and the pain and suffering people go through when both internal and external forces result in tragedy. We are unable to erase the past and are charged with the task of seeking justice by taking into consideration each individual case's evidence and the impact of each case on all people involved. I have often faced decisions in which I could take the easy route to satisfy some. However, my duty as prosecutor is to insure the integrity of our legal system for everyone.

One of the most serious examples is when I have been called upon to make the decision on when to seek the death penalty. When I first took office there were two capital murder cases pending. I reviewed both of those cases and decided to withdraw the death penalty as an option on both. I did so after careful consideration of the evidence and the impact on our community. Since taking office, I have also had to make this difficult decision in other cases. I have sought and received the death penalty in one case, declining to seek it in other cases. The decisions I was called upon to make in these cases involved both professional and personal reflection at the deepest level. I met with much advice during the process from various sources, but at the end of the day, the decisions were mine alone to make. These decisions were met with both extreme criticism and praise, reinforcing the adage that difficult decisions never satisfy everyone.

As prosecutor, I have had to make other very difficult decisions on a myriad

of cases. Each one was unique and affected the people involved in different ways. My experience as Prosecutor in making these types of decisions has been an excellent preparation for assuming the role as a judge. I know the process for making these decisions must transcend any concept that justice is about winning and losing. Rather these decisions are an immense responsibility that must take into account everyone who will be affected by the outcome, and the impact they may have on our community.


